Location: Waunakee HS Pool, 100 School Dr., Waunakee, WI 53597

Facility: Eight lanes, 25 yards flush deck, non-turbulance lane dividers and backstroke flags, with 18" height starting blocks. Pool is 7.5 feet deep at the starting blocks and 3.5 feet deep at the non starting end of the pool.
100 yard relays will have the 2nd and 4th leg of the relay start in the water.

Timing: Colorado System with backup watches. All events are timed final. Computerized score board for all lanes.

Officials: Head official: Don Heinz. There will be at least three certified USA Swimming Officials on deck at all times.

Rules: This meet will be conducted under 2008 USA Swimming and Wisconsin Swimming rules. Registered USA swimmers are invited to participate.

Warm-ups: Morning warm-ups will be at 7:15-8:15 am with competition starting at 8:30 am. General warm-up/circle swim for the first 30 minutes. The second 30minutes, sprint lanes will be opened as needed by the meet marshal. PM warm up session will begin immediately after the completion of the am session, but not before 11:00 and will last 60 minutes. **SIT AND SLIDE ENTRY ONLY FROM THE STARTING END OF THE POOL**, unless performing one way starts. Lane assignments will be available in the coaches' packets. Meet Marshall will be on deck during the entire warm up, with the authority to recommend disqualification.

Deadline: Swimmers may compete in 4 individual events and 2 relays. All teams are requested to submit entries in the Hy-Tek commlink format .Emailed **Hy-Tek Entries are due May 21st**. You will receive an e-mail confirmation of your entry with in 48 hours. If you have not received that confirmation, please call Tim Amundsen at 608-850-4652. Entry fees: \$2.00 LCS splash fee/swimmer, \$3.00/ individual event, and \$12.00 per relay

Deck Entries: The entry fee for deck entries will be \$5.00 (\$15.00 for relays) in addition to the \$3.00 entry fee (\$12 for relays). Deck entries will be allowed to fill open lanes. No additional heats will be added. Deck seeding will close 30 minutes prior to the start of each session.

Age Groups: 6 and under, 7-8, 9-10, 11-12, 13-14, Senior Age as of May 31, 2008

Awards & Scoring: This meet will be scored through 16th place with relays counting double. Awards for relay events will consist of ribbons for 1st-8th place. Awards for individual events will consist of ribbons for 1st-16th place. Coaches will be permitted to pick up awards at the end of the meet. Awards will not be mailed.

Admissions: \$3.00. 11 and younger free. (\$1.00 off with the donation of a personal care item {shampoo, toothpaste, etc} or cleaning supply for the food pantry)
\$3.00 heat sheets

Concessions: A large selection of hot and cold food and drinks will be available throughout the day. **FOOD AND DRINK IS NOT ALLOWED IN THE POOL AREA.**
BOTTLED WATER IS PERMITTED.

Conduct: All teams are responsible for the conduct of their swimmers. The meet Director/Marshall, at his/her discretion, shall remove any swimmers or spectators who behave in a disruptive or disorderly manner.
