this meet. Swimmers must be registered WI USA Swimming swimmers.

Swimmers' age is as of June 9, 2007. No recall starts.

RELAYS: All relay events will be awarded ribbons based on 1st - 6th place, however relays

will **not** count towards individual high points trophies.

WARM-UPS: The first 30 minutes of each warm-up session is circle swimming only, no diving

from the starting blocks. The next 30 minutes: Lanes 2, 3, 4, 5, and 6 will be open for sprints with diving from the blocks permitted. Lanes 1, 7 and 8 will be

for circle swimming.

ENTRIES: Completed entry forms, signed waiver, and fees must be received by **Friday**, **May** 

**25th, 2007**. Preferred method of entry is by e-mail in HY-TEK COMMLINK format. If sending a disk, it MUST be accompanied by a hard-copy listing of entries. Current USS ID number MUST be included on the entry form. If e-mailing entries, hard copy, waiver and fees must be received by Tuesday, May
