The Committee began a discussion of Re-Certification Clinic Agenda items, including guidelines/procedures for "Delay of Meet" and new situations/questions developed by the USA Swimming Officials Committee. The Committee decided to defer establishing an agenda until the October Meeting to permit members to review the new situations/questions.

**Officials Review Board Hearing of July 8, 2003:** An Officials Review Board of Michelle Koehler, Steve Surprenant, Chair, and Susan Taylor reviewed a complaint against an Official for conducting a Meet with only two Officials and only one team. The second Official at the Meet made the compliant. By consensus, and effective immediately, the Committee agreed:

- To reassign the Official from Starter-Referee to Stroke and Turn Judge until the Official participates in a Starter/Referee Officials Clinic, achieves a score of at least ninety percent (90%) on the written USA Swimming tests for Starter, Referee, Administrative Referee, Clerk of Course, and Timing Judge and completes the shadow requirements for Starter/Referee of five (5) sessions in two (2) Meets for Starter and six (6) sessions in three (3) Meets for Referee; and
- 2) To revoke the individual's certification as USA Swimming Official should the person continue to work as a Starter/Referee prior to completion of these requirements.

Zblewski will revise the Wisconsin Swimming Officials Directory on the website.
