Age-Group & Senior Committee Meeting April 12, 2006

Regionals Review: Feedback from the SWAT/EBSC Regional was positive (satisfying timeline and meet size).

12 & Under State Review: Confusing event order, can we standardize meet information?, Meet Manager file online developed by LSC?, officiating was good – but some issues with who's running the meet, awards were positive, get away from Prelim/Final format for awards?, and bag awards at all WI LSC Championship meets.

13 & Over State Review: Complicated to run finals with Hy-tek software – very time involved (13-14, 15-16, and Senior events had to be cut and pasted to produce the Finals heat sheets – the program wants to run all girls - 13-14, 15-16, and Senior - and then all boys without alternating age-groups and genders), did ask Hy-tek to rewrite program but they were not receptive, Hy-tek program also pulls a 15-16 swimmer from the Senior division for Finals even if the 15-16 swimmer wanted to swim Senior, likes/dislikes of mass Prelims/split Finals (hurts 13-14 Girls?, fast swimming in the AM), and officials (get away from started/administration referee from same team, rating system for officials?).

Dates for 2007 (tentative): Regionals (February 16-18), 12 & Under (February 23-25), 13 & Over (March 1-4), and Speedos (March 8-11).

LCM Championship Preview: discussed size and length (last summers 13 & Over State meet was very long with Prelims running right up to Finals), flow for 12 & Under meet or lack there of (a lot a breaks during last summers meet – good, bad, or indifferent?), numbers from the 2005 12 & Under summer meet indicate the size of the meet for this summer should be fine, 13 & Over summer meet needs some tweaking (proposing event order change instead of adjusting qualifying times, i.e., making them faster), 13 & Over event order change (Thursday will be the 200 Medley Relay and the 800 Free – Friday will be the Senior 200 Free Relay to start the Prelim session – Saturday will be the 13-14 200 Free Relay to start the Prelim session), with these changes the 13 & Over summer meet should have a bearable number of swimmers/spectators during the Prelim sessions), and look for tighter qualifying times for the 13 & Over state meets in 2007.

Silver Meet: The range for qualifying for this meet are finalized – see attached (the range is BB to .01 slower than WI LSC State qualifying times for 10 & Under, 11-12, and Senior), the assignments for North or South Silver Meet's have been finalized (see attached), meet entries are due 10 days in advance (to help develop timelines and warm-up schedules if need be to be posted on the WI LSC website), and if any team wants to switch from the Waukesha Silver meet to the Howard-Suamico Silver meet please speak with Age-Group Chair.

Travel Fund: Discussion held concerning Peter Healy's Travel Fund document, many questions, and do we need to raise more money for the Travel Fund?

Zones: Fred Russell of EBSC has a letter from WIAA clearing the way for WI LSC swimmers to participate in Zones and Juniors without ramifications.
