STARTING TIME Morning sessions: Warm ups 7:00a.m. to 8:00p.m.

Afternoon sessions: Warm ups will begin immediately following the morning session.

Meet **will not** start before 12:00p.m.

WARM UPS The first 30 minutes of the warm up session will be lap swimming, entering the pool feet first only. The next 30 minutes lanes 3, 4, 5, and 6 will be sprint swimming only. Lanes 1, 2, 7, and 8 will be for lap swimming.

SEEDING: All age groups will be pre-seeded.

TIMING: All events will be conducted as timed finals using a Colorado Timing System with two back up watches per lane.

POOL: A 25 yd. 8 lane pool with non-turbulence lane markers and backstroke flags. Block height is 30" at a pool depth of 14'.

ENTRIES: Entries will be limited to 1600 individual entries per day. Each swimmer will be restricted to five (5) individual events per day plus relays. Swimmers age as of October 10, 1999 will determine his/her age group. **Deck entries will be accepted if open lanes are available and number of entries permit.** Deck registrations **will not** be accepted.

Current U.S. Swimming rules for competitive swimming and the Wisconsin General Committee Rules shall prevail. All swimmers must have a current USS card for verification at the meet. Coaches must display USS cards when on the pool deck at all times.

THIS MEET IS BEING RUN USING HY-TEK SOFTWARE. PLEASE SUBMIT ENTRIES ON A 3.5 DISK AND INCLUDE A PRINTED COPY OF THE ENTRIES.

ADAPTIVE SWIMMERS: If you are entering an adaptive swimmer, please notify meet officials of any such handicaps.

ENTRY FEES: \$2.00 per individual event. \$6.00 per relay team and \$1.25 splash fee per swimmer payable to **SOUTH WEST AQUATIC TEAM**. Entry fees must accompany entry forms. Any fees accepted for this meet will not be refunded.

OUT OF STATE All out of state swimmers must show a current USS card.

SCORING: 1st, 2nd, and 3rd place individual High Point awards will be given for each age group and sex. Individual scoring will be 9, 7, 6, 5, 4, 3, 2, and 1 for the top eight finishers.

AWARDS: Medals for 1st-3rd and ribbons for 4th- 8th on all individual events in each class. 6 & Under, 8& Under and Seniors will be awarded in one class. Relays will be awarded ribbons 1st- 8th. Heat winner ribbons will be awarded and achiever medals will be awarded. All 8 & Under swimmers will receive ribbons. Plaques will be awarded to High Point individuals.

ADMISSION: \$2.00 plus \$2.00 for a heat sheet. Results will be provided to all participating teams at no charge. Additional result sheets may be purchased at the admission table for \$10.00.

FOOD: A full menu will be offered at reasonable prices throughout the meet.

MEET CONDUCT: It is expected that each club will be responsible for the conduct of their swimmers. If in the opinion of the Meet Director, a swimmer's conduct is harmful to others or property, the swimmer will be asked to leave the meet.
