

- REGISTRATION: not be allowed to exceed meet entry limits and all deck entries must be completed **30 minutes prior to the start of the session**. Decision to grant entry is up to the meet director. **NO DECK ENTRIES WILL BE DONE AFTER THE DEADLINE**. There will be a surcharge of \$3.75 plus entry fees = (\$7.50) for anyone wishing to be deck seeded. All swimmers must currently be registered with USA Swimming.
- CHECK-IN: Swimmers in the **1000 Free** must **check in by 5:30 PM**; events 1 and 2 heats may be combined.
- TIMING SYSTEM: All events will be timed using a Dakronics Timing System with horn start, touch pads, one button, and minimum of one watch as backup.
- DISABILITY SWIMMERS: Please indicate on the entries form any special needs for those athletes requiring assistance. Also, please inform the head official of those needs **prior** to the start of the meet.
- AWARDS: **There will be no awards for the Friday night Senior races.**
- OFFICIALS: There will be at least three certified USA Swimming Officials on deck at all times. Head Referee is Ben Radloff.
- RULES: This meet will be conducted under USA Swimming 2009 and Wisconsin Rules.
- MEET CONDUCT: Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshall, is harmful to others or to other's property will be required to leave the competition.
In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.
- ADMISSIONS: \$2.00 per session admission for 12-older for the session.
Programs will be available for \$4.00 for the session.
- FINAL RESULTS: Teams that submitted entries via e-mail will need to bring a disk or provide an e-mail contact/address to receive results after the conclusion of the meet. On the waiver form, please circle whether you want a Commlink or a Meet Manager back up.
- CONCESSIONS: Delicious hot and cold foods will be available for purchase throughout the meet.
