**Location:** Brookfield East High School  
3305 Lilly Road  
Brookfield, WI 53005

**Facility:** Six (6) lanes, 25 yard indoor pool, backstroke flags, non-turbulent lane dividers, 3.5 feet minimum depth. Height of blocks is 30 inches, depth of pool at starting blocks is 12 feet. **Depth of pool at turn end requires 2<sup>nd</sup> and 4<sup>th</sup> leg of 100 yard relays to begin in the water.** Timing will be Colorado electronic timing system with touch pads and two watch back-up per lane. The Competition course has not been certified in accordance with 104.2.2 (C).

**Rules:** Official 2010 USA Swimming Short Course rules shall prevail at this meet. Coaches must display their current membership cards while on deck.

**Eligibility:** Swimmers must be registered with USA Swimming. Age is as of Jan. 9, 2010.

**Schedule:** Morning session warm-ups will start at 7:00am. Feet first three point entry during general warm-ups will be enforced. Sprint lanes will be opened at the discretion of meet director. Meet begins at 8:05am. Afternoon session warm-ups will begin immediately following the conclusion of the morning session. The afternoon session will begin 65 minutes after completion of the morning session.

**Entries:** Swimmers are limited to a total of three individual events. Clubs may enter an unlimited number of relay teams. All entered times must be in yards. This will be a pre-seeded meet. Any special requirements for swimmers should also be noted on the entry forms.

**Entry Fees:** Fees are \$4.00 per individual event, \$10.00 per relay. Add \$3.00 LSC Splash fee per each individual swimmer.

**Entry Deadline:** Completed entry forms, waiver, and fees must be received by the Meet Director no later than December 22, 2008. Late entries will NOT be accepted. This meet will be run using Hytek Meet Manager software. Please include hardcopy with all disk entries. **Admissions:** \$3.00 for all spectators over 12 years of age. Heat Sheet \$2.00. All spectators must remain in designated viewing area; only meet participants and personnel will be allowed on the pool deck.

**Awards:** Custom awards for 1<sup>st</sup>-3<sup>rd</sup> place in individual events. Ribbons for the 4<sup>th</sup> – 16<sup>th</sup> Place finishers in individual events. Ribbons for 1<sup>st</sup>-6<sup>th</sup> Place for relay events. Custom awards for those B – C swimmers achieving A or BB times. In keeping with our Hawaiian theme, leis will be awarded to all heat winners.

**Concessions:** Food and beverages will be sold.

**Conduct:** Teams will be responsible for conduct of swimmers. Meet marshals will enforce safety rules. In compliance with Video Protection Act, the use of any recording devices in locker rooms is prohibited.

**Meet Results:** Final results will be e-mailed to teams and posted to WI Swimming website.
