Facility: Six (6) lanes, 25 yard indoor pool, backstroke flags, non-turbulent lane dividers, 3.5 feet minimum depth. Height of blocks is 30 inches, depth of pool at starting blocks is 12 feet. Depth of pool at turn end of 3.5 feet requires 2nd and 4th leg of 100 yard relays to begin in the water. The competition course has not been certified in accordance with 104.2.2C(4).

Timing: 3 manual watches per lane

Rules: Official 2011 Short Course USA Swimming and WI Swimming rules shall govern the conduct of this meet. Coaches must display their certification cards while on deck.

Eligibility: Swimmers must be registered USA swimmers. Age is as of June 3, 2011.

Schedule: Warm-ups will run from 5:00 p.m. to 5:50 pm. There will be general warm-up in lanes 1-6 with sit and slide entries only. 25 yd sprints in lanes 2, 3, 4, and 5 to be announced by meet manager. Meet begins at 6:00 p.m.

Entries: Swimmers are limited to a total of four (4) individual events. Clubs may enter an unlimited number of relay teams. All entered times must be in yards. This will be a pre-seeded meet. Please indicate on the entry form any special needs your swimmers may have.

Entry Fees: \$4.25 per individual entry; \$10.00 per relay entry. Add \$2.00 LSC Splash fee per each individual swimmer.

Entry Deadline: Completed entry forms, waiver, and fees must be received by the Meet Director no later than Tuesday May 26, 2011. Late entries will NOT be accepted. This meet will be run using Hytek Meet Manager software. Please include hardcopy with all disk entries. Deck Entries: Coaches may deck-seed swimmers to the limit of filling heats at the discretion of meet management. Entries will not be allowed to exceed meet entry limits. No new heats will be opened. There will be a surcharge of \$5.00 plus entry fees for all deck entries.

Admissions: \$3.00 for all spectators over 12 years of age. Heat Sheet \$2.00. All spectators must remain in balcony viewing area; only meet participants and personnel will be allowed on the pool deck.

Awards: Medals will be awarded 1st through 3rd place and ribbons 4th through 16th place for individual events. Ribbons will be awarded 1st through 6th place for relay events. Heat winners will be awarded.

Concessions: Food and beverages will be sold.

Conduct: Teams will be responsible for conduct of swimmers. Meet marshals will enforce safety rules. In compliance with Video Protection Act, the use of any recording devices in locker rooms is prohibited.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement
