- Location:** Brookfield East High School

Brookfield, WI 53005
- Facility:** Six lanes, 25 yd indoor pool, backstroke flags, non-turbulent lane dividers, 30 inch block height with 12 feet depth at starting end and 3.5 feet depth at the turning end. Depth at turn end requires 2nd and 4th legs of 100 yard relays to begin in the water. This competition course has not been certified in accordance with 104.2.2C(4).
- Timing:** At least two manual watches per lane for 25 yard events. Two manual watches back-up per lane and Colorado timing system for all other events.
- Rules:** Official 2011 Short Course USA Swimming rules shall govern this meet. Coaches must display their certification cards while on deck.
- Eligibility:** Swimmers must be registered USA swimmers. Age is as of October 8, 2011.
- Officials:** Dave Westcott (Head Official)
- Schedule:** Feet first three point entry will be enforced during general warm-ups. Morning Warm-ups will begin at 7:00 a.m and end at 7:45am. Sprint lanes will be opened at discretion of meet director. Meet begins at 7:50 a.m. Second Session warm-ups will start immediately following the completion of first session and will last 45 minutes. Second session will begin 50 minutes after the completion of the first session.
- Entries:** Swimmers are limited to a total of four individual events. Clubs may enter an unlimited number of relay teams. All entered times must be in yards. This will be a pre-seeded meet. Please indicate on entry form any special needs your swimmers may have.
- Entry Fees:** \$4.25 per individual entry; \$10.00 per relay entry; \$2.00 LSC splash fee.
- Entry Deadline:** Completed entry forms, waiver, and fees must be received no later than Wednesday, September 28th, 2011. Late entries will not be accepted. Deck Seeding: Coaches may deck enter swimmers at the discretion of meet management. No new heats will be opened. Deck entry fee is \$5. No USA Swimming Membership deck registration will be accepted.

Awards: 1st-3rd place high point awards will be given in each age group. High point Awards may be given to coaches. Custom awards will be given for 1st-3rd place and ribbons will be awarded for 4th-16th place. Relay ribbons will be awarded for 1st-6th place. Heat winners will be given for all events.

Admissions: \$3.00 for all spectators over 12 years of age. Heat sheets are \$2.00. All spectators must remain in balcony viewing area. Only meet participants and personnel will be allowed on pool deck.

Concessions: Food and beverages will be sold.

Conduct: Teams are responsible for conduct of their swimmers. In compliance with Video Prevention Act, the use of all recording devices in locker rooms is prohibited.

Only Coaches, swimmers, officials, and meet workers are allowed on deck.

Coaches must show current USA Swimming coaching certification while on deck.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
