- Location:** Brookfield East High School

Brookfield, WI 53005
- Facility:** Six (6) lanes, 25 yard indoor pool, backstroke flags, non-turbulent lane dividers, 3.5 feet minimum depth. Height of blocks is 30 inches, depth of pool at starting blocks is 12 feet. Depth of pool at turn end of 3.5 feet requires 2<sup>nd</sup> and 4<sup>th</sup> leg of 100 yard relays to begin in the water. The competition course has not been certified in accordance with 104.2.2C(4).
- Timing:** At least two manual watches per lane for 25 yard events. Two manual watches back-up per lane and Colorado timing system for all other events.
- Rules:** Official 2012 USA Swimming Short Course rules shall prevail at this meet. Coaches must display their current membership cards while on deck.
- Eligibility:** Swimmers must be registered with USA Swimming. Age is as of January 7, 2012.
- Schedule:** Morning session warm-ups will start at 7:00 am and end at 8:00am. Feet first three point entry during general warm-ups will be enforced. Sprint lanes will be opened at the discretion of meet director. Meet begins at 8:05 am. Afternoon session warm-ups will begin immediately following the conclusion of the morning session. The afternoon session will begin 65 minutes after completion of the morning session.
- Entries:** Swimmers are limited to a total of 4 (four) individual events. Clubs may enter an unlimited number of relay teams. All entered times must be in yards. This will be a pre-seeded meet. Any special requirements for swimmers should also be noted on the entry forms.
- Entry Fees:** Fees are \$4.25 per individual event, \$10.00 per relay. Add \$2.00 LSC Splash fee per each individual swimmer.
- Entry Deadline:** Completed entry forms, waiver, and fees must be received by the Meet Director no later than December 19, 2011. Late entries will NOT be accepted. This meet will be run using Hytek Meet Manager 3.x software. Please include hardcopy with all disk entries. **Deck Seeding:** Coaches may deck enter swimmers at the discretion of meet management. No new heats will be opened. Deck entry fee is \$5. No USA Swimming Membership deck registration will be accepted.

**Officials:** Dave Westcott (Head Official)

**Admissions:** \$3.00 for all spectators over 12 years of age. Heat Sheet \$2.00. All spectators must remain in balcony viewing area; only meet participants and personnel will be allowed on the pool deck.

**Awards:** Custom awards for 1<sup>st</sup>-3<sup>rd</sup> place in individual events. Ribbons for the 4<sup>th</sup> – 16<sup>th</sup> Place finishers in individual events. Ribbons for 1<sup>st</sup>-6<sup>th</sup> Place for relay events. Custom awards for those B – C swimmers achieving A or BB times. In keeping with our Hawaiian theme, leis will be awarded to all heat winners.

**Concessions:** Food and beverages will be sold.

**Conduct:** Teams will be responsible for conduct of swimmers. Meet marshals will enforce safety rules. In compliance with Video Protection Act, the use of any recording devices in locker rooms is prohibited.

Only Coaches, swimmers, officials, and meet workers are allowed on deck.

Coaches must show current USA Swimming coaching certification while on deck.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**Meet Results:** Final results will be e-mailed to teams and posted to WI Swimming website.
