- Location:** Franklin Wirth Park
2580 North Pilgrim Road
Brookfield, WI 53005
- Facility:** Five (5) lanes, 50 meter outdoor pool, backstroke flags, non-turbulent lane dividers, 4 ft. minimum depth. 18 inch block height, with 4 feet depth at start at start and finish ends. This competition course has not been certified in accordance with 104.2.2C(4).
- Timing:** Colorado electronic timing system with touch pads and two watch back-up on events 100 meters or greater. Timing on all 50 meter events will be three stopwatches per lane.
- Rules:** Official 2012 Long Course USA-Swimming rules shall prevail at this meet. Coaches must display their certification cards while on deck. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Eligibility:** Swimmers must be registered with USA-Swimming. Age is as of July 15, 2012.
- Schedule:** AM session: Warm-ups will start at 7:00am. Meet begins at 8:05am.
- PM session: Warm-ups will begin immediately following the conclusion of the AM session. Competition begins 65 minutes after start of warm-ups, but not before 11:00am.
- Format: First 30 minutes: general warm-up (circle swim) in lanes 1-5; sit and slide entry only. Second thirty minutes: sprint lanes will be allocated at meet manager's discretion. AM session swimmers may warm down in the diving well under supervision of a coach; however, the diving well is closed during the PM session of the meet.
- Entries:** Swimmers are limited to a total of four (4) individual events. Clubs may enter an unlimited number of relay teams. All entered times must be in meters. This will be a pre-seeded meet. Please note any special requirements for swimmers on entry forms.

Entry Fees: Fees are \$4.25 per individual event, \$10.00 per relay. Add \$2.00 LSC Splash fee per each individual swimmer.

Entry Deadline: Completed entry forms, waiver, and fees must be received by the Meet Director no later than Tuesday, July 3, 2012. Late entries will NOT be accepted. This meet will be run using Hytek Meet Manager software. Please include hardcopy with all disk entries. Deck Seeding: Coaches may deck-seed swimmers to the limit of filling heats and at the discretion of meet management. There will be a surcharge of \$5.00 plus entry fees for all deck entries. No USA Swimming Membership deck registration will be accepted.

Officials: Dave Westcott (Head Official)

Admissions: \$3.00 for all spectators over 12 years. Heat sheet \$2.00. All spectators must remain in designated viewing area; only meet participants and personnel will be allowed on the pool deck.

Awards: Medals will be awarded for 1st-3rd place in individual events, with ribbons to 16th place. Relay ribbons will be awarded for 1st-6th place. Heat winners will be awarded in the afternoon session only.

Inclement Weather: Except in extreme weather conditions, decision to postpone or cancel meet will be made at Wirth Park by the pool manager. Decision to postpone or cancel while meet is in progress will be made by pool manager. All entry fees will be refunded upon cancellation of entire session. Entry fees for cancelled individual events will be refunded in case of cancellation of a partial session.

Concessions: Food and beverages will be available at reasonable prices.

Conduct: Teams will be responsible for conduct of swimmers. Meet marshals will enforce safety rules. In compliance with Video Protection Act, the use of any recording devices in locker rooms is prohibited.

Only Coaches, swimmers, officials, and meet workers are allowed on deck.
