- POOL:** Eight 7 foot lanes, flush deck gutter system, non-turbulent Wave Eater II lane markers, backstroke flags, and 30" inch high starting platforms. Pool depth is 9'0" at the starting end, 4' at the non-starting end, 8 position scoreboard, and complete sound system. The Competition Course has not been certified in accordance with USA Swimming's Rule 104.2.2(c).
- Description:** Two Session, Pentathlon, Swimmers register for all 5 events. Relays are available.
- AGE GROUPS:** 7 & under, 8, 9, 10, 11, 12, 13, 14, 15 and over.
- TIMING SYSTEM:** Colorado System 5 electronic timing system with strobe/horn start, 8 touch pads, with manual backup timing buttons except for 25 yard events which will be hand timed with electronic stopwatches; each lane will have 2 timers with electronic stopwatches. All events will be timed finals.

WARM UPS:

First 1/2 hour circle swim only in all lanes. Second 1/2 hour circle swims lane 1, 2, and 8. Push Pace 50's lanes 3 and 7. One way sprints lanes 4, 5, and 6. **Swimmers must enter the water with a sitting slide in entry, except for the One Way Sprints.**

A coach from your team must be on deck during warm-ups. Swimmers not following procedures could be disqualified at the discretion of meet officials.

ENTRIES:

A maximum of 1200 entries will be accepted for this meet. This meet will be run using Hy-Tek meet manager. All teams are encouraged to submit entries on a disk or via email in the Hy-Tek commlink format. A hard copy of entries must accompany a disk. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

ENTRY DEADLINE: The entry chair must receive a completed entry form and signed waiver no later than **Tuesday, June 14th**. No entries will be taken over the phone. Email entries are encouraged and can be sent to: reedc@mail.fortschools.org
