Description:	Two Session Pentathlon, swimmers register for all 5 events. Relays available.		
Age Groups:	6 & Under, 7, 8, 9, 10, 11, 12, 13, 14 and over.		
Facility:	Eight 7 foot lanes, flush deck gutter system, non-turbulent Wave Eater II lane markers, backstroke flags, and 30" inch high starting platforms. Pool depth is 9'0" at the starting end, 4'0" at the non-starting end, 8 position scoreboard, and complete sound system. The Competition Course has not been certified in accordance with USA Swimming's Rule 104.2.2 C(4).		
Timing System:	Colorado System 6 electronic timing system with strobe/horn start, 8 touch pads, with manual backup timing buttons except for 25 yard events which will be hand timed with electronic stopwatches; each lane will have 2 timers with electronic stopwatches. All events will be timed finals.		
Rules:	Official 2012 Short Course USA Swimming Rules and Wisconsin Swimming Rules shall govern the conduct of this meet. Swimmers must be registered USA swimmers. Age is as of June 16, 2012. Coaches must display their Coaches Card while on deck. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.		
Schedule:	Warm-up 8:00-9:00 AM, meet starts at 9:05 AM. A coach from each team must be on deck during warm-ups. Swimmers not following procedures could be disqualified at the discretion of meet officials. The afternoon warm-ups will start as soon as the morning session has been completed, with the afternoon session beginning one hour and 5 minutes after the start of warm-ups. The meet director will notify each club as to the approximate time for all sessions once all meet entries have been received.		
Seeding:	All individual events will be pre-seeded and will stop at 8:00 AM (1 hour before the start of the meet).

- Entries & Eligibility:** All entries will be taken when accompanied by full payment. Swimmers may compete in FIVE (5) individual events per day plus relays. All swimmers must be registered USA Swimming swimmers and MUST be listed on the official entry form. This includes relay only swimmers. Submit current yard times. All events will be timed finals. Completed entry form, signed waiver, and fees must be received no later than Monday June 4, 2012. Any questions concerning entries should be directed to Bill Foster, Meet Manager at 608-436-6955 or psefoster@yahoo.com.
- Entry Fees:** \$22.00 per individual - \$4 x 5 events plus \$2.00 per swimmer for LSC tax splash fee. \$10.00 per relay event.
Entry fees must accompany the official entry forms and are not refundable.
- Admissions:** \$3.00 per spectator over the age of 12. Heat sheets are \$3.00.
- Raffle:** Raffle to be held at the end of each session. Need not be present to win.
- Awards:** Ribbons for individual events places 1-10 and relay events places 1-3.
High Point Trophies will be awarded to 1st – 6th place per single age. Places will be determined by the total points. Participation ribbons will be given to all swimmers 8 and under.
- Medical:** Please indicate any special needs your swimmers may have on the entry form. We will do everything possible to accommodate them. This should include any existing conditions that may require meet management to activate the emergency response plan. Building personnel are trained in procedures required by Blood Borne Pathogens laws and will be responsible for any clean up required.
- Final Results:** Final results will be posted at www.wisconsinswimming.org
- Conduct:** Each team is responsible for the behavior of their swimmers. In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited. The Meet Director or Meet Marshall may remove any swimmer from competition for disruptive or disorderly behavior.
- Coaches:** All coaches must pick up their coach's packet in person and must show their coach's card. If a coach does not present a USA Swimming registration card they will not be allowed on deck and the swimmers for the team will be assigned to a USA Swimming certified coach for warm-ups.
- Food:** Food and beverages will be sold at all sessions.
