DATE: July 17-19, 2009

HOST : Fond du Lac Swim Club (FSC)

LOCATION: Fond du Lac's, 50 meter, Taylor Park Pool*
104 Mary's Avenue
Fond du Lac, WI 54935

*In the event of forecasted lightening storms, the meet may take place at the Fond du Lac Community Aquatic Center; 100 W. 9th Street, Fond du Lac, WI 54935. Determination of forecasted lightning storms will be made 48 hours prior to the start of the meet and head coaches will be notified.

FACILITY: Six lane, 50 meter pool. Pool depth is 12 feet at the start end and 3 feet at turn end. Blocks are 29.5 inches high. This competition course has not been certified in accordance with USA Swimming's Rule 104.2.2(c).

CLASSIFICATION: Approved/Open, Wisconsin LSC dictated.

RULES & ELIGIBILITY: 2009 USA and Wisconsin LSC rules shall prevail for this meet. Swimmers should be registered with USA Swimming; however, this meet is open to YMCA Swimmers as well. Age as of July 17, 2009.

QUALIFICATION: *There are no qualifying times for this meet.*

SCHEDULE: All warm-up sessions and meet start times will be determined after entries are received.

WARM-UPS: General warm-ups/circle swimming in all lanes for each warm-up session. Push-pace and sprint lines will be opened and closed as necessary by the Meet Director and Meet Marshals. Sit and slide entry will be enforced during general warm-ups.

ENTRY LIMIT: 7 events total for the meet (no more than 5 on any one day).

RELAYS: Relays will not be contested.

- ENTRY FEES: \$4.00 per event
\$3.00 per WI LSC Splash fee per swimmer.
- DECK SEEDING: Deck entries will be accepted until a half hour into warm-ups and in open lanes only. Deck entries are \$6.00 per event
- NON-CONFORMING: DO NOT CONVERT. Swimmers must be entered at their best time. The order used for seeding will be LCM-SCM-SCY. All courses will be used. Non-conforming times will be seeded after LCM times.
- TIMING SYSTEM: Colorado System 6 timing system with touch pads and horn start.
- DISABLED SWIMMERS: Please indicate on the entry form any special needs for those athletes requiring assistance. Also, please inform the Head Official of those needs prior to the start of the meet.
- AWARDS: 1st – 16th place ribbons will be awarded.
High Point: 1st – 3rd place in each age group
- COACHES: All coaches must pick up their coach's packets in person and must show their coach's card. If a coach does not present appropriate identification, they will not be allowed on deck and the swimmers for the team will be assigned to a certified coach for warm-ups.
- SCORING: 16 place scoring will be used.

- MEET CONDUCT: Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshall, is harmful to others or to the other's property will be required to leave the competition. Please sit in designated areas for teams. All swimmers must keep their swim bags in the team sitting areas. All spectators must sit in approved spectator seating. In accordance with USA Swimming rules.
- In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.

Time Trials

WI Sanction # 2009 - 139WI (TT)

TIMES: Time Trials will be offered on Sunday and as time permits at the discretion of the Meet Director as per LSC mandate. Swimmers are encouraged to provide timing assistance if possible.

EVENTS: See meet order of events listing.

FEES: \$8.00/event, no relays will be offered.

REGISTRATION: Entries will be accepted during all sessions, through Sunday morning. Meet management will announce deadline for time trials, which will be early Sunday afternoon. If a swimmer is not signed up for the meet they must be able to prove they are a registered swimmer for 2008/9.

PROCEDURE: Swimmer will complete a seed card at the table – swimmer's name, age, team, event name, and seedtime. Seed card and event fee must be turned into the Meet Management table before the registration deadline. A meeting for all Time Trial participants and timers will be held prior to the start of Time Trials. Cards with heat and lane assignments will be handed out during the meeting. It is the swimmer's responsibility to be ready to swim when her/his event, name, and lane number is called. The Referee will not hold the start of the event, waiting for a swimmer (or timer) to show up. An announcement will be made that Time Trials are beginning and swimmers and timers should report to the meeting immediately. All Time Trial cards (whether or not a swimmer swims a desired time) MUST be turned in at the end of each heat.

REMEMBER: The maximum number of individual events in one day is five (5) and includes Time Trials (USA 102.2.5 and 102.2.6). This means that a swimmer may swim 5 individual events total in one day, including a combination of:

- 1) only Time Trials
 - 2) combined Time Trials and meet events
- or
- 3) only meet events

Time Trials will begin promptly. It is the responsibility of the swimmer to be at the blocks, complete with her/his timers, ready to swim.

Timers must turn in their cards whether or not a swimmer achieves a desired cut time.
