\*\*\*In the event of forecasted lightning storms, the meet may take place at the Fond du Lac Community Aquatic Center; 100 W. 9<sup>th</sup> Street, Fond du Lac, WI 54935. Determination of forecasted lightning storms will be made 48 hours prior to the start of the meet and head coaches will be notified.

FACILITY: Six lane, 50 meter, heated pool. Pool depth is 12 feet at the start end and 3 feet at turn end. Blocks are 29.5 inches high. This competition course has not been certified in accordance with USA Swimming's Rule 104.2.2C(4). This outdoor pool is heated.

CLASSIFICATION: Silver Meet Time Standards, WI LSC dictated

RULES & ELIGIBILITY: 2011 USA and Wisconsin LSC rules shall prevail for this meet. Swimmers must be currently registered with USA Swimming. Age as of July 15, 2011. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member / coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

QUALIFICATION: *There are no qualifying times for this meet.* There are no qualifying times for this meet. Swimmers may enter and compete in any event in which they do not have the state qualifying time. The time standards are listed at [www.wisconsinswimming.org](http://www.wisconsinswimming.org). If a swimmer makes the qualifying time in an event after the meet entries have been submitted, they will be allowed to compete in that event at this meet and the State Meet.

If a swimmer, age 14 or under, has achieved the state cut in a given race, they can enter the Senior age group for that event, if and only if, they have NOT achieved the state cut in the Senior age group. Any swimmer that has already achieved the Senior cut is not allowed to swim that race.

- WEATHER DELAY:** If weather delays are necessary we will make every attempt to complete all events. If it is necessary to cancel events, entry fees will not be refunded.
- SCHEDULE:** All warm-up sessions and meet start times will be determined after entries are received. Once entries are completed a timeline will be sent to all teams entered.
- WARM-UPS:** General warm-ups/circle swimming in all lanes for each warm-up session. Push-pace and sprint lines will be opened and closed as necessary by the Meet Director and Meet Marshals. Sit and slide, or three point entry will be enforced during general warm-ups.
- ENTRY LIMIT:** 7 events total for the meet (no more than 5 on any one day).
- RELAYS:** No Relays will be offered
- ENTRY DEADLINE:** Wednesday, July 6, 2011

- ENTRY FEES:** \$4.00 per event  
\$2.00 per WI LSC Splash fee per swimmer.
- DECK ENTRIES:** Deck entries will be accepted until a half hour into warm-ups and in open lanes only. No addition heats will be added. Deck entries are \$6.00 per event, plus WI LSC Splash fee of \$2.00 if the swimmer is not already entered in the meet. USA Swimming deck registrations will not be accepted.

- FORMAT / SEEDING** It is the swimmer's responsibility to be at the blocks at the start of his/her events. This is a time final meet. All events will be pre-seeded with exception of the 400 Free, 800 Free and the 1500 Free events.
- The 400, 800, and 1500 will be positive check-in. The check in for these events will close 30 minutes prior to the start of the session which the events are in. These events will be swum fastest to slowest, alternating girls and boys. The Wisconsin Scratch rule will be in effect for this meet.
- Heats / events may be combined, but will be awarded as separate age group
- NON-CONFORMING:** DO NOT CONVERT. Swimmers must be entered at their best time. The order used for seeding will be LCM-SCM-SCY. All courses will be used. Non-conforming times will be seeded after LCM times.
- TIMING SYSTEM:** Colorado Timing System with touch pads and plungers at each end. Two stop watches per lane, and horn start.
- DISABLED SWIMMERS:** Please indicate on the entry form any special needs for those athletes requiring assistance. Also, please inform the Head Official, and Meet Director of those needs prior to the start of the meet.
- AWARDS:** Individual: 1<sup>st</sup> – 16<sup>th</sup> place ribbons will be awarded.  
High Point: 1<sup>st</sup> – 3<sup>rd</sup> place in each age group  
Team Award: 1<sup>st</sup> – 3<sup>rd</sup> place
- COACHES:** All coaches must pick up their coach's packets in person and must show their coach's card. If a coach does not present appropriate identification, they will not be allowed on deck and the swimmers for the team will be assigned to a certified coach for warm-ups. Coach's cards must be visible at all times on deck.
- SCORING:** 16 place scoring will be used.

- TIME TRIAL #:** **WI2011-260TT**
- TIMES:** Time Trials will be offered on Sunday and as time permits at the discretion of the Meet Director as per LSC mandate. Swimmers are to provide two timers, and a person to count laps (if needed).
- EVENTS:** See meet order of events listing.
- FEES:** \$8.00/event, no relays will be offered.
- REGISTRATION:** Entries will be accepted during all sessions, through Sunday morning. Meet management will announce deadline for time trials, which will be early Sunday afternoon. If a swimmer is not signed up for the meet they must be able to prove they are a registered swimmer for 2011.
- PROCEDURE:** Swimmer will complete a seed card at the table – swimmer's name, age, team, event name, and seedtime. Seed card and event fee must be turned into the Meet Management table before the registration deadline. A meeting for all Time Trial participants and timers will be held prior to the start of Time Trials. Cards with heat and lane assignments will be handed out during the meeting. It is the swimmer's responsibility to be ready to swim when her/his event, name, and lane number is called. The Referee will not hold the start of the event, waiting for a swimmer (or timer) to show up. An announcement will be made that Time Trials are beginning and swimmers and timers should report to the meeting immediately. All Time Trial cards (whether or not a swimmer swims a desired time) **MUST** be turned in at the end of each heat.
- REMEMBER:** The maximum number of individual events in one day is five (5) and includes Time Trials (USA 102.2.5 and 102.2.6). This means that a swimmer may swim 5 individual events total in one day, including a combination of:
- 1) only Time Trials
  - 2) combined Time Trials and meet events
  - 3) only meet events
- Time Trials will begin promptly. It is the responsibility of the swimmer to be at the blocks, complete with her/his timers, ready to swim. Timers must turn in their cards whether or not a swimmer achieves a desired cut time.
