FACILITY: Six lane, 50 meter pool. Pool depth is 12 feet at the start end and 3 feet at turn end. Blocks are 29.5 inches high. This competition course has not been certified in accordance with USA Swimming's Rule 104.2.2(c). Please be advised that due to the depth of the non-starting end of the pool, the 2<sup>nd</sup> and 4<sup>th</sup> leg of all 100-Yard/Meter relays will start in the water.

CLASSIFICATION: Sanctioned/Open

**RULES & ELIGIBILITY:** 2010 USA and Wisconsin LSC rules shall prevail for this meet. Swimmers should be registered with USA Swimming, age as of June 19, 2010.

- WARM-UPS:** Warm ups to start at 7:00am-8:00AM. The meet starts at 8:05. The PM warm ups start immediately following the end of the AM Session and will last 1 hour. General warm-ups/circle swimming will be in all lanes for each warm-up session. Push-pace and sprint lines will be opened and closed as necessary by the Meet Director and Meet Marshals. Sit and slide or 3 point entry will be enforced during general warm-ups.
- ENTRY LIMIT:** 8 events total for the meet (no more than 4 on any one day plus relays: use best Long Course Meter Times).
- ENTRY FEES:** \$4.00 per event/ \$12 per relay  
\$3.00 per WI LSC Splash fee per swimmer.
- DECK SEEDING:** Deck entries will be accepted until a half hour into warm-ups and in open lanes only. Deck entries are \$6.00 per event and \$15 per relay.
- TIMING SYSTEM:** Colorado System 6 timing system with touch pads and horn start.
- DISABLED SWIMMERS:** requiring assistance. Also, please inform the Head Official of those needs prior to the start of the meet.
- AWARDS:** Seniors- None: – 14 & Under ribbons will be awarded 1<sup>st</sup>-16<sup>th</sup> place. Relays will be awarded 1<sup>st</sup>-6<sup>th</sup> place ribbons.
- COACHES:** All coaches must pick up their coach's packets in person and must show their coach's card. If a coach does not present appropriate identification, they will not be allowed on deck and the swimmers for the team will be assigned to a certified coach for warm-ups.
- OFFICIALS:** Head Official: Michael Patton
- MEET CONDUCT:** Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshall, is harmful to others or to the other's property will be required to leave the competition. Please sit in designated areas for teams. All swimmers must keep their swim bags in the team sitting areas. All spectators must sit in approved spectator seating in accordance with USA Swimming rules.

In accordance with the Federal Video Voyeurism Prevention Act of 2004 –the use of camera phones or video recording devices in the locker rooms is prohibited.
