1. Sanction: WI2012-212S
2. Location: Howard-Suamico Pool  
Lineville Intermediate School

Green Bay, WI 54313
3. Facility: Indoor 25 yard pool with 6 lanes, non-turbulent lane markers, backstroke flags. The pool depth is 9 feet at starting end and 3.5 at turn end. Block height is 30 inches. The 2<sup>nd</sup> and 4<sup>th</sup> leg of all 100-yard relays must start in the water from a push-start due to pool depth.  
**The Competition course has not been certified in accordance with 104.2.2C(4)**
4. Timing/Judging: All events will be timed finals. Colorado timing system with touchpads will be used, with two manual watches per lane.
5. Official Rules: Current USA-S and Wisconsin Swimming rules shall govern the conduct of this meet. The no recall start rule will be in effect.

7. Warm-up: First 20 minutes – Circle swim all lanes 1-6  
Next 40 minutes – Lanes 1 & 6 Sprints  
Lanes 2,3,4,5 Circle swim  
Other sprint lanes will be opened as needed.  
Three-point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition.
8. Eligibility: All swimmers must be registered USA-S swimmers and their USA-S number must be listed on the entry form. No “applied for” entries will be accepted. All out-of-state swimmers must be prepared to show their USA-Swimming cards at the request of the meet director. Age is as of June 2, 2012.
9. Entry Deadline: All entries must be received no later than Wednesday, 5/23/2012. Please submit entries on HyTek e-mail or CD if possible. Deck entries will be accepted from the coach the day of the meet (provided they do not result in a new heat) up to one half hour prior to the start of each session and will cost \$5.00 per entry.

10. Entry Limit: Swimmers may compete in a maximum of 4 individual events on Saturday and 3 individual events on Sunday. (7 total for the Meet)

14. Awards: Awards will consist of medals for 1<sup>st</sup>-3<sup>rd</sup> place and ribbons for 4<sup>th</sup>-16<sup>th</sup> place for individual events, and ribbons for 1<sup>st</sup>-5<sup>th</sup> place for Relays. Heat winners will receive awards. \*\* Please note that the 400IM, 1000 Free Events (31, 32, 89, & 90) will be awarded as either 12 & Under OR 13 & Older.
15. Admission: Admission \$4 for 13 & older and \$2 for senior citizens. A heat sheet fee will be available for \$5 at the door. We will have limited heat sheets for sale at the meet. **Heat sheets will be available for free online at [www.hssb-wi.org](http://www.hssb-wi.org) the day before the meet for all attendees to print out.**
16. Coaches Note: All coaches must pick up their coaches packets in person and must show their current USA-S coaches card. If a coach does not present a USA-S card they will not be allowed on deck and the swimmers from that team will be assigned a USA-S certified coach for warm-ups. **Positive check-in of swimmers required for the 400IM, 1000 Free Events (31, 32, 89, and 90)**
17. Concessions: Food and beverages will be sold during the meet and must be consumed in designated areas.
18. Conduct: Each club is responsible for the conduct of its swimmers. All teams please keep your area as clean as possible. In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.  
**Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.**
19. Disabled Swimmers: If you have a disabled swimmer, please note on entry form.
20. Lead Official: Cindy Maltry
21. Seating: **Due to crowding in the pool area we request that all swimmers avoid staying in the bleacher area.**
