Facility: Six lanes, 25 yards flush deck, non-turbulence lane markers and backstroke flags, with 30" height starting blocks. Pool is 7 feet deep at starting blocks and 4 feet deep on the shallow end. The Competition course has not been certified in accordance with 104.2.2C(4). Please be advised that due to the depth of the non-starting end of the pool, the 2nd and 4th leg of all 100-Yard relays will start in the water.

Timing: Colorado System with backup watches. All events are timed final. Computerized scoreboard for all lanes.

Head Official: Joe Domitrz

Official Rules: Official 2011 Short Course USA-S Rules shall prevail for this meet. Swimmers must be registered swimmers. Age as of February 13, 2011.

Warm-up: Warm-ups will be 8:30am-10am, with the meet starting at 10:05am. Teams will be assigned lanes. Sit and slide entry will be enforced during warm-up procedures.

Entry Limit: Swimmers may swim four (4) individual events plus two (2) relays.

Fees: Individual events \$3.50 per event and \$12.00 per relay. \$3 LSC surcharge per swimmer swimming in at least one individual event. Entry fees must accompany the official entry forms and are not refundable.

Entry Deadline 1: *All participants will be receiving participation gifts.* This early entry is due so that we can finalize t-shirt orders (if we choose that gift), so each child receives a shirt that fits appropriately. A second entry deadline is available to **UPDATE TIMES** only.

The entry chair must receive **e-mail entry files** and **paper entries** (no hy-tek software) **no later than Monday, January 31st**. This meet is being run with Hy-Tek swim software. Deck entries will be accepted in open lanes only.

Entry Deadline 2: **Monday, February 7th (8pm)** – for updating times only. Completed waivers are payments are due by Thursday, February 10th.

Disabled Swimmers: If you have any disabled swimmers, please notify the Meet Director by e-mail or phone no later than Thursday, February 10, 2011.

Admissions: Spectators over 13 years old are \$3. Heat sheets are \$2.

Final Results: One copy of final results will be sent to each team represented. Teams will be responsible to pick up their commlinked disk following the completion of the meet. No awards or disks will be mailed with the final results.

Concessions: A concession stand with a wide and delicious variety of food and beverages will be available.

Conduct: Each team is responsible for the conduct of its' swimmers. In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.

Awards: All swimmers will receive a participation gift (t-shirt or other item). A fun raffle will also be held, for all participants.

Heat winner awards will be given in all events.

The top 18 swimmers will score. Highpoint awards will be given in each gender and age group (5&Under, 6, 7, and 8 years old). The following scoring system will be used, beginning with the first place score:

25-23-22-21-20-19	1 st -6 th place
17-15-14-13-11-11	7 th -11 th place
9-7-6-5-4-3	13 th -18 th place

Individual Events:	1 st - 18 th	Ribbons
All relay events:	1 st - 3 rd	Rosette Ribbons

Unaccompanied Swimmer: Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
