Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

	Feet first three-point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition in accordance with the recent change to Policy 4.5.2(a).		
<b>COACHES MEETING</b>	There will be a coach's meeting prior to the start of each session if determined necessary by the Meet Referee.		
<b>ELIGIBILITY</b>	All swimmers must be current (2011) members of USA Swimming.		
<b>EVENTS</b>	All events will be timed final events. An event schedule for this meet is included with this meet announcement. Events will be offered in the following age categories: 8 & under, 9/10, 11/12, and Senior. Events 37, 39/40, 42, 45, 47, 86, 87/88, 89, 94 and 96 <b>may</b> be limited to three heats based on submitted entry times. Please review the event list to verify heat limitations. Heats will be swum fastest to slowest seeded heats.		
<b>EVENT LIMITATIONS</b>	Heat limitations will <i>only</i> be imposed if necessary to manage the timeline. It is our intent to swim as many heats as possible. Swimmers may enter and swim five (5) individual events each day. To check seeding for heat-limited events visit the LFSC website ( <a href="http://www.swimlfsc.org">www.swimlfsc.org</a> ) after October 24, 2011.		
<b>ENTRY FEES</b>	\$4.50 per individual event. Deck entries will be accepted if open lanes are available, entry fee is \$6.00. A swimmer surcharge of \$2.00 per swimmer entered in individual events must be included with entry. <b>Make checks payable to "Lake Forest Swim Club"</b> .

**ENTRIES**

Please submit short course yard entry times. All entry times must be achieved in accordance with USA Swimming rules prior to the entry deadline. All entries must be submitted on the entry forms attached or facsimiles thereof. The attached summary form, release and hold harmless statement, and all entry fees must accompany all entries. Failure to comply with any entry requirement will be sufficient cause to refuse entry.

Submit all entries in Hy Tek® file format. A printed copy of the entry, all forms, waivers, and summaries, and a check for entry fees must be received within 96 hours of receipt of entry. The host club accepts no responsibility for receipt of e-mail entries. Confirmation of receipt is the sole responsibility of the sender.

**SEEDING**

All swimmers are required to check-in and positively declare their intent to swim for each event. Swimmers who do not check-in will be scratched from that event. **Special seeding procedures will be used for disability athletes (see USA Rule 202.2.13).**

Coaches are encouraged to notify the meet host of scratches in advance of the meet *via* FAX (847.735.6198) and e-mail [LFSCentries@sbcglobal.net](mailto:LFSCentries@sbcglobal.net).

**AWARDS**

All swimmers will receive awards for 1st - 10th place in individual events for 8 & under, 9/10, 11/12, age groups.

Heat winner prizes will also be awarded.

**DECK ACCESS AND CREDENTIALS**

Only contestants, coaches, and working meet officials will be granted access to the competitive area. Current USA Swimming membership card must be continuously displayed while on deck. Coach's information packets will be available at the meet.

**SWIMMER SUPERVISION**

Each team or coach is responsible for the supervision of his or her swimmers. Swimmers and their families are allowed access to the pool area, concession areas, and designated rest areas, subject to USA Swimming and Wisconsin Swimming rules. The locker rooms are for changing purposes only: no lockers will be available for swimmers participating in the meet. The meet and/or facility host reserves the right to remove from the meet any swimmer entering an unauthorized area.

In accordance with the Federal Video Voyeurism Prevention Act of 2004, the use of camera phones or video recording devices in the locker rooms is prohibited.
