When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

<b>COACHES MEETING</b>	There will be a coach's meeting 15 minutes prior to the start of each session if determined necessary by the Meet Referee.		
<b>ELIGIBILITY</b>	All swimmers must be current (2012) members of USA Swimming.		
<b>EVENTS and SEEDING</b>	All events will be timed final events. An event schedule for this meet is included with this meet announcement. Events will be offered in the following age categories: 8 & under, 9/10, 11/12, 12 & under, 13/14 and Senior. The 13/14 age group and Sr. class will be combined for competition.  The Sr 800 free, 400 free and the 12 & under 400 free will be swum fastest to slowest seeded heats. The Sr 400 free and 800 free <i>may</i> be swum alternating women's and men's heats.		
<b>EVENT LIMITATIONS</b>	Heat limitations will <i>only</i> be imposed if necessary to manage the timeline. It is our intent to swim as many heats as possible. Swimmers may enter and swim five (5) individual events plus relays each day.  The following events may be limited to three heats based on submitted entry times: <ul style="list-style-type: none"><li>• 8 &amp; under 100m events</li><li>• Sr 800 free and all 200m events</li><li>• 12 &amp; under 200 IM and 400 Free</li></ul> To check seeding for heat-limited events visit <a href="http://www.swimlfsc.org">www.swimlfsc.org</a> after June 5, 2012.

<b>ENTRIES</b>	Please submit long course meter entry times. All entry times must be achieved in accordance with USA Swimming rules prior to the entry deadline. All entries must be submitted on the entry forms attached or facsimiles thereof. The attached summary form, release and hold harmless statement, and all entry fees must accompany all entries. Submit all entries in Hy Tek® file format.	
<b>SEEDING</b>	All swimmers are required to check-in and positively declare their intent to swim for each event. Swimmers who do not check-in will be scratched from that event. <b>Special seeding procedures will be used for disability athletes (see USA Rule 202.2.13).</b>	
	Coaches are encouraged to notify the meet host of scratches in advance of the meet <i>via</i> FAX (847.735.6198) and e-mail <a href="mailto:LFSCentries@sbcglobal.net">LFSCentries@sbcglobal.net</a> .	
<b>AWARDS</b>	Awards will be given for 1st – 10 <sup>th</sup> place in individual events for 8 & under, 9/10, 11/12 and 12 & under age categories.	
	Heat winner prizes will also be awarded.	
<b>DECK ACCESS AND CREDENTIALS</b>	Only contestants, coaches, volunteer meet support, timers and working meet officials will be granted access to the competitive area. Current USA Swimming membership card must be continuously displayed while on deck.	
<b>SWIMMER SUPERVISION</b>	Each team or coach is responsible for the supervision of his or her swimmers. Swimmers and their families are allowed access to the pool area, concession areas, and designated rest areas, subject to USA Swimming and Wisconsin Swimming rules. The locker rooms are for changing purposes only: no lockers will be available for swimmers participating in the meet. The meet and/or facility host reserves the right to remove from the meet any swimmer entering an unauthorized area.
