

# Waterloo Chamber of Commerce Small Team Invitational

Sanction #2010-110WI

- Date: January 23, 2010
- Location: Waterloo High School  
Madison Street  
Waterloo, WI 53594
- Classification: Classification for all swimmers will be A-B-C combined. All relay events will be A-B-C combined.
- Facility: Six (6) lanes, 25-yard pool with non-turbulent lane markers, backstroke flags, and 28" blocks. Pool depth is 3.5 ft. at its shallow end and 10 ft. at starting block end. The 2<sup>nd</sup> and the 4<sup>th</sup> leg of the 100 yard relays will be required to start in the water. Ample parking available in the high school parking lot and seating in the pool area. The Competition course has not been certified in accordance with 104.2.2(C).
- Timing System: Colorado electric timing system with touch pads and manual back-up buttons and horn start. Each lane will have two timers with electronic stop watches.
- Meet Time Schedule: *AM Session: Warm ups 7:30 - 8:30 AM*  
*Meet Begins: 8:40 AM*  
*PM Session: Warm-ups for PM session will last 60 minutes*  
*Warm-ups for the P.M. session will not begin before 11:00 AM Afternoon session will begin 65 minutes after the morning session but not before 12:05 PM.*
- Warm Ups: The first half hour of each warm up session will be circle swim only in all lanes. The last half hour, lanes 1,2, and 3 will be for one way sprints, diving from the block permitted. Feet first three-point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition.

- Officials: Head Official: Dan Lapin; Stroke and Turn: TBD; Starter/Referee: TBD
- Eligibility: All teams must hold current 2009-2010 USA Swimming memberships. All swimmers must also have a current 2009-2010 USA Swimming registration. Swimmers age as of January 23, 2010 shall determine age group eligibility. All out of state swimmers must register with the Meet Director prior to entering the water: a valid USA Swimming membership card must be presented. Coaches acting in a coaching capacity must have passed the required certification tests and must display the current membership card.

- Rules:** Current Wisconsin Swimming, Inc. and USA Swimming rules will govern this meet. This is a short course meet.
- Entries:** Only the first 900 entries will be accepted. Entries not accepted will be notified by phone and reservation money will be refunded. Swimmers may compete in up to four (4) individual events plus two (2) relays. This will be a pre-seeded meet. The 1000 Freestyle will be swum in a mixed format, but will be scored by age groups and sex. The 1000 freestyle will be limited to 3 heats. The top 18 times will be taken and will be seeded fastest to slowest. NT entries will be accepted if there are not 18 entries with official seed times and the NT will be accepted in the order the entries are received. All swimmers are expected to be at the blocks, ready to swim, when their events and heats are announced. Deck entries will be permitted in unfilled heats only, and at the discretion of the Meet Director. Deck seeding will close at 8:00 AM for the morning session and 11:30 AM for the afternoon session. "Please indicate on the entries form any special needs for those athletes requiring assistance. Also, please inform the head official of those needs prior to the start of the meet."
- Entry Deadline:** Send completed waiver, entry forms, and entry fees to the Meet Director no later than Jan 11, 2010. **Late entries will not be accepted after Tuesday before the meet except for deck seeding the day of the meet.** The meet will be run using Hy-Tek Meet Manager. Meet entries on disc or e-mail using Hy-tek Meet Manager is highly encouraged. Scoring will be computerized.
- Fees:** Entry fees are \$4.00 for individual events (\$5.00 for deck seed), \$12.00 for relays (\$15.00 for deck seed), and a \$3.00 splash fee per swimmer. Entry fees must accompany entry forms. Make checks payable to: Waterloo Swim Club. Fees are non-refundable.
- Admission:** Admission is \$2.00 for adults. There is no admission fee for students. Heat sheets are \$5.00. Coach's packets will be available at the computer table. Coaches and club officials desiring to be on deck will be required to display proof of current USA Swimming membership at all times.
- Awards:** Individual events: 1<sup>st</sup>-3<sup>rd</sup> Medals for both individual and relay events; 4<sup>th</sup> – 16<sup>th</sup> ribbons will be awarded to individuals; 4<sup>th</sup>-8<sup>th</sup> ribbons will be awarded to relays. Heat winner awards will be given to all 10&U events.
- Scoring:** Points will be awarded 1<sup>st</sup> through 16<sup>th</sup> place per the default on HyTek Meet Manager. The Open Mixed 1000 freestyle and relays count double points. Only the top three swimmers in each event will score team points, and only the top relay team per event will score points. Team trophies will be awarded to all participating teams.
- Concessions:** Food and beverages will be available at reasonable prices in the high school cafeteria and must be consumed in the cafeteria.
- Meet Results:** Each team will be mailed one copy of the meet results. Additional copies will be available for \$5.00 per copy and may be purchased by contacting the Meet Director.
- Conduct:** It is expected that each club will be responsible for the conduct of their swimmers in all areas of the high school. A rest area will be provided in the high school cafeteria for the swimmers. If in the opinion of the meet marshals and/or Meet Director, a swimmer's conduct is harmful to others or property, they will be asked to leave the meet. In accordance with the Federal Video Voyeurism Prevention

Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.

### WAIVER FORM
