TIMING: Events will be timed and judged by Colorado automatic timing system and

judging equipment. Colorado horn starting system. Two back-up timers per lane

will be provided.

EACH SWIMMER WILL BE LIMITED TO FIVE (5) INDIVIDUAL EVENTS. **ENTRIES**:

> Swimmer's age as of February 5, 2011 will determine his/her age group. **Deck** entries will be accepted if open lanes are available and number of entries

permit. Parents should come to the pool office to complete the forms.

**ENTRY DEADLINE:** 

Completed individual and relay entry forms, waiver and fees must be received

no later than January 21, 2011. All entries should be submitted either

on the enclosed entry form or on a Hy-tek Team Manager file. Submit all seed times in yard cutoff times. Be sure to indicate any UNATTACHED swimmers. Hytek entries will be accepted and are preferred. Please include a hard copy

with all file entries.

**ENTRY FEES:** \$3.50 per individual event and \$3.00 splash fee per swimmer. Entry fees must

> accompany entry forms. Recap statement must be complete and the waiver form signed. Money used for reservations is nonrefundable and cannot be used to offset cost of deck seeding or splash fees. **SEEDING:** All age groups will be pre-seeded.

**ELIGIBILITY:** All swimmers must be currently registered with United States Swimming and the

USA numbers must appear on the entry form/disk. Out of state entrants must bring their USA swimming cards and be prepared to show them to Meet Director. Swimmers wishing to deck enter must have their current USA Swimming ID card

available.

**AWARDS**: Individual Events Ribbons – 1<sup>st</sup>-12th

Heat winner awards will be given for all events for 10 and under age groups. High Point Awards 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> by age groups 8&U, 9 and 10 for individual event scores. High Point awards will be presented to the individual winners at the conclusion of the meet. All ribbons and trophies will be available for pick-up

during the meet. No awards will be mailed.

**ADMISSION**: \$3.00 plus \$3.00 for heat sheet

**COACHES**Coaches may pick up their packets in the pool office. Any monies owed must be paid before you can obtain your packet. Please be prepared to show your

USA Swimming coaches card at the time you pick up your team packet. Coach's

cards must be visible at all times on deck.

**OFFICIAL RULES:** 2011 USS Wisconsin Swimming Rules shall govern this meet.

**DISABLED** Please notify meet officials of any disabled swimmers upon arriving at meet.

**SWIMMERS:** 

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the

responsibility of the swimmer or the swimmer's legal guardian to ensure

compliance with this requirement.

**FIRST AID**: A First Aid kit will be available in the pool office.

**LOST&FOUND:** Located in the pool office. After the meet, please contact the meet director. Lost

& found will only be held for two weeks after the meet. Any remaining items will

then be donated to charity.

**FINAL RESULTS:** Will be posted on the Wisconsin Swimming website and e-mailed to participating

teams. They will also be posted in the pool lobby during the meet.

**REST AREA:** The rest area will be restricted to the pool and the hallways adjacent to the pool.

Swimmers will not be allowed in other areas of the school.

**SMOKING:** Per USA Swimming rules, smoking is NOT permitted in areas designated for

swimmers, including the rest areas and pool.
