**TIMING:** Events will be timed and judged by Colorado automatic timing system and

judging equipment. Colorado horn starting system. Two back-up timers per lane

will be provided.

ENTRIES: EACH SWIMMER WILL BE LIMITED TO FOUR (4) INDIVIDUAL EVENTS.

Swimmer's age as of February 4, 2012 will determine his/her age group. **Deck** entries will be accepted if open lanes are available and number of entries

permit. Parents should come to the pool office to complete the forms.

ENTRY DEADLINE:

High Point awards will be presented to the individual winners at the conclusion of the meet. All ribbons and trophies will be available for pick-up by the coaches at the conclusion of the meet. No awards will be

mailed.

compliance with this requirement.
