**FACILITY:** Indoor, 25 yard pool with 10 lanes with non-turbulent lane lines. Pool depth 7' at the shallow end and 12' at the deep end. Starting blocks are 29.5". The competition course has been certified in accordance with USA Swimming Rule 104.2.2C(4). The copy of such certification is on file with USA Swimming.

**TIMING SYTEM:** Fully automated Colorado timing system .

\* **Approximate times:** Warm-ups will begin immediately after the conclusion of the morning session, but not before Noon. Positive Check-In will close 20 minutes after the start of warm-ups. The meet will begin 1 hour after the start of warm-ups.

**GENERAL RULES:** All USA Swimming, Inc. and WI LSC rules apply, including Safety rules, which will be strictly enforced. Wisconsin Swimming warm-up procedures will be in effect. Feet first three-point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition in accordance with the recent change to Policy 4.5.2(a). Warm-up will begin with 30 minutes of circle swimming in all lanes. Sprint lanes will be opened as needed during the second 30 minutes. Violators of the Wisconsin Swimming Warm-up procedure are subject to disqualification.

**ELIGIBILITY:** All swimmers must be current (2012) members of USA Swimming. USA Swimming deck registrations will not be accepted. A swimmer's age for the meet will be his/her age as of January 28, 2012.

**COACHES:** Coaches must be current members of USA Swimming, Inc. to be allowed on deck, and must display their current registration card at all times.

**SEEDING:** All events will be timed finals, seeded slowest to fastest. For seeding purposes, please submit Short Course Yard times. Special seeding procedures will be used for disability athletes (see USA Rule 202.2.13).

**CONDUCT:** All clubs will be responsible for their own swimmers. Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. In accordance with

the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.

- ENTRY FEES:** Individual events are \$4.00 each. A surcharge of \$2 per swimmer entered in individual events must be included with your entry. Please make all checks payable to **Mundelein Mustang Swim Club**.
- ENTRY LIMIT:** Swimmer may enter and swim four (4) individual events per day.
- ENTRY** Entries will be accepted starting November 1. Team entries on Hy-Tek Disk, hard copy, waiver and fees must be received by the Entry Chair no later than **Thursday, January 5, 2012**. Send forms, waiver and entry to Mundelein Mustang Swim Club, P.O. Box 1017, Mundelein, IL 60060.
- AWARDS:** Ribbons for 1-8<sup>th</sup> place in all individual events for 8&under, 9-10, 11-12 age categories. Swimmers in the Open category will not receive awards.
- ADMISSIONS:** The admission charge for all spectators over the age of 12 will be \$5.00 per day. Psych sheets or Heat Sheets will be available at the door,
- CONCESSIONS:** Food and drink will be available from the concession stand during the meet.  
No glass containers are permitted on deck.
- VENDORS:** Kiefer will be on site Saturday and Sunday
- MEET RESULTS :** A copy of the Final Results will be provided to each participating team in the same format that their entry was received. Meet results will be posted on the MMSC website following the conclusion of the meet.
- TIMERS:** Each team is required to provide timers for one lane for the complete meet. Timing assignments will be posted in several places around the deck and the concession area. Timing needs will be determined closer to the start date of the meet.
- OFFICIALS:** There will be a need for officials to help this meet run smoothly. Certified officials should contact Barbara Schober , [Bardan795@gmail.com](mailto:Bardan795@gmail.com). Any assistance that can be provided with starting or refereeing will be greatly appreciated.
