REMINDER: September 29-30<sup>th</sup>, 2012 is a CLOSED weekend due to Wisconsin Swimming/USA Swimming's Swimposium. NO MEETS WILL BE SANCTIONED AND/OR APPROVED for competition that weekend.

<u>APPROVED MEETS</u>: Any team requesting to host an "approved" meet must also complete Form F and this form must accompany your meet bid. The Sanctioning Chair will then forward the request (along with a copy of the meet information) to USA Swimming for their approval.

REMINDER: The 2013 Winter Championship hosted meets have already been voted on at the April 2012 House of Delegates meeting and will appear on the UNOFFICIAL Schedule.
