## Things you need to know about the 2010 Winter Short Course Meet Schedule

- Meet reservations are sent to the Meet Director listed.
- **Meets requiring reservations need to be turned in for sanctioning by AUGUST 1<sup>ST</sup>, 2010 and posted on Wisconsin Swimming's website prior to SEPTEMBER 14<sup>TH</sup>, 2010**

Meet Reservations **cannot** be **postmarked** any earlier than **SEPTEMBER 14<sup>TH</sup>, 2010**

Meet Reservation forms are available in the LSC Handbook or online at the Wisconsin Swimming website ([www.wisconsinswimming.org](http://www.wisconsinswimming.org))

- ONCE A MEET HAS BEEN SANCTIONED – IT IS THE HOST CLUB'S RESPONSIBILITY TO HAVE THIS DIRECTED TO DALE NICKELS FOR POSTING ON WISCONSIN SWIMMING'S WEBSITE ([dnickels@ipswitch.com](mailto:dnickels@ipswitch.com)).  
It is NOT the responsibility of the Administrative Chair to post the meet on the website!
- **ANY** changes made to your meet information after it has been approved/sanctioned needs to be re-directed to the Administrative Chair for any okay – in many cases a new sanction/approval will need to be administered.

- Remember! Meet information must have an assigned approval or sanction number from the Administrative Chair **before** mailing to any other teams. LSC rule 11.2.1 imposes a \$75 fine to clubs that don't abide by this rule.

- Meet information date deadlines helpful to meet directors:

\*8 weeks before Meet Date

Send draft of meet information to Administrative Chair (2 weeks for a dual/tri meet)

\*For meets not requiring a reservation

21 days before Meet Entry Deadline

Postmark meet information to clubs with reservations or invited

2 weeks after Meet

EMAIL meet results to all teams and LSC (Meet Reports available online at website) – Refer to Policy 2.4 for recent revisions!

21 days after the Meet

ELECTRONICALLY FILE meet reports to LSC
