Things you need to know about the 2008 Summer Long Course Meet Schedule

- Meet reservations are sent to the Meet Director listed.
- Meets requiring reservations need to be turned in for sanctioning by February 1st, 2008 and posted on Wisconsin Swimming's website prior to March 11th, 2008.

Meet Reservations **cannot** be **postmarked** any earlier than **March 11th, 2008**. Meet Reservation forms are available in the LSC Handbook or online at the Wisconsin Swimming website (<u>www.wisconsinswimming.org</u>)

- ONCE A MEET HAS BEEN SANCTIONED IT IS THE HOST CLUB'S RESPONSIBILITY TO HAVE THIS DIRECTED TO DALE NICKELS FOR POSTING ON WISCONSIN SWIMMING'S WEBSITE (<u>dale@stdnet.com</u>) – It is NOT the responsibility of the Administrative Chair to post the meet on the website.
- <u>ANY</u> changes made to your meet information after it has been approved/sanctioned needs to be re-directed to the Administrative Chair for any okay in many cases a new sanction/approval will need to be administered.
