- Meet reservations are sent to the Meet Director listed.
- **Meets requiring reservations need to be turned in for sanctioning by February 17<sup>th</sup>, 2009 and posted on Wisconsin Swimming's website prior to March 10<sup>th</sup>, 2009.**

Meet Reservations cannot be postmarked any earlier than March 10<sup>th</sup>, 2009.

Meet Reservation forms are available in the LSC Handbook or online at the Wisconsin Swimming website ([www.wisconsinswimming.org](http://www.wisconsinswimming.org))

- ONCE A MEET HAS BEEN SANCTIONED – IT IS THE HOST CLUB'S RESPONSIBILITY TO HAVE THIS DIRECTED TO DALE NICKELS FOR POSTING ON WISCONSIN SWIMMING'S WEBSITE ([dale@stdnet.com](mailto:dale@stdnet.com)) – It is NOT the responsibility of the Administrative Chair to post the meet on the website.
- **ANY** changes made to your meet information after it has been approved/sanctioned needs to be re-directed to the Administrative Chair for any okay – in many cases a new sanction/approval will need to be administered.

21 days after the Meet
