- Meet reservations are sent to the Meet Director listed.
- Meets requiring reservations need to be turned in for sanctioning by February 15<sup>th</sup>, 2011 and posted on Wisconsin Swimming's website prior to March 8<sup>th</sup>, 2011
  Meet Reservations cannot be postmarked any earlier than MARCH 8<sup>th</sup>, 2011
  Meet Reservation forms are available in the LSC Handbook or online at the Wisconsin Swimming website (www.wisconsinswimming.org)
- ONCE A MEET HAS BEEN SANCTIONED IT IS THE HOST CLUB'S RESPONSIBILITY TO HAVE THIS DIRECTED TO DALE NICKELS FOR POSTING ON WISCONSIN SWIMMING'S WEBSITE (<u>dnickels@ipswitch.com</u>). It is NOT the responsibility of the Administrative Chair to post the meet on the website!
- **<u>ANY</u>** changes made to your meet information after it has been approved/sanctioned needs to be re-directed to the Administrative Chair for any okay in many cases a new sanction/approval will need to be administered.

- Remember! Meet information must have an assigned approval or sanction number from the Administrative Chair **before** mailing to any other teams. LSC rule 11.2.1 imposes a \$75 fine to clubs that don't abide by this rule.
