- Meet reservations are sent to the Meet Director listed.
- **Meets requiring reservations need to be turned in for sanctioning by February 14, 2012 and posted on Wisconsin Swimming's website prior to MARCH 13<sup>TH</sup>, 2012**  
 Meet Reservations **cannot** be **postmarked** any earlier than **MARCH 13<sup>TH</sup>, 2012**  
 Meet Reservation forms are available in the LSC Handbook or online at the Wisconsin Swimming website ([www.wisconsinswimming.org](http://www.wisconsinswimming.org))
- ONCE A MEET HAS BEEN SANCTIONED – IT IS THE HOST CLUB'S RESPONSIBILITY TO HAVE THIS DIRECTED TO DALE NICKELS FOR POSTING ON WISCONSIN SWIMMING'S WEBSITE ([dnickels@ipswitch.com](mailto:dnickels@ipswitch.com)).  
 It is NOT the responsibility of the Administrative Chair to post the meet on the website!
- **ANY** changes made to your meet information after it has been approved/sanctioned needs to be re-directed to the Administrative Chair for any okay – in many cases a new sanction/approval will need to be administered.
