ELIGABILITY:	Swimmers age as of February 13, 2010. All teams must hold current 2010 USA Swimming memberships. All swimmers must have valid 2010 USA Swimming membership cards. Out-of-State swimmers must bring their USS cards with them. Coaches must display their current 2010 membership cards.		
EVENTS:	Senior 400 IM, , events 103 &	pre-seeded timed final, except events 1-4, 13-14 and 2104, 13-14 500 Free, 105&106, Senior 500 Free, and D Free, which will be deck seeded. Positive check-in and	

scratches are required for these deck-seeded events at the scorers table prior to the start of the session which these events are in. All swimmers will swim as one class by age group and sex.
