Directions <u>From HWY 51/39</u>: Exit 185; Proceed North on Old 51 to Cty Road XX; Right onto Cty XX and go around 3 right angle bends to a "T" in the road with Cty X; Left onto Cty Rd X which becomes Pleasant and Camp Phillips; Drive east and north; Turn left onto Howland Av. <u>From Hwy 29</u>: Exit Camp Phillips Road; Proceed South on Camp Phillips to Howland Ave. Turn right onto Howland.

Time Check-in: 9:00 AM Clinic: 9:15 AM – 1:00 PM

Fee: *Please* <u>pre</u>-registration to insure availability of sufficient Clinic materials. Fees include USA Swimming CD, "Officiating Swimming" and a USAS Mini Rule Book. *USA Swimming:* \$25; Most Clubs reimburse participants for this fee and the USA Swimming Non-Athlete Membership fee, \$55 for 2011.

YMCA: \$35; Participants should check with their teams about reimbursement.

At the Clinic: The Clinic includes reviewing the USA Swimming CD on strokes, turns, relay exchanges, and deck jurisdictions. Lecture and lots of discussion are expected. Please bring pen and paper for taking notes. All other materials provided. Wausau Woodson Y provides appropriate snacks and beverages.

After Clinic:

USA Swimming: Applicant must apply on-line for a Background Check prior to applying for USAS Non Athlete Membership. Wisconsin Swimming reimburses the applicant for the \$39 Background Check after the applicant sends a copy of the invoice to Pat Lewno, LSC Treasurer, 5330 Linden Circle, Racine 53406. Then a participant must take USA Swimming on-line, open book tests and apprentice for four sessions on the pool deck. After certification as a Stroke and Turn Judge, Wisconsin Swimming provides the new Officials with an Officials polo shirt and name badge. Volunteer often to officiate any Team's Meet.

YMCA: Take the YMCA on-line, open book test.
