Clinic: Training session is a combined USA Swimming Starter-Referee and/or YMCA Level II Clinic.

Prerequisites: Participants must be at least 21 years old and, if seeking...

USA Swimming Certification: Be a current USA Swimming Stroke and Turn Judge Official or YMCA Level II Official; have at least 1 year experience; and have officiated 10 or more sessions in the prior year.

YMCA Certification: Be affiliated with a recognized YMCA swim team; be a current YMCA Level I certified Official or a USA Swimming Stroke and Turn Judge Official for at least 1 year; and have officiated at least 8 sessions.

- *For YMCA Level II Re-certification,* must have worked at least 12 sessions as a Level II Official in the previous 3 years. For dual certified USA Swimming/ YMCA Officials, up to 6 of these sessions may be from USA Swimming meets.

USA Swimming participants will have membership verified electronically, prior to Clinic.

YMCA participants must bring written membership documentation to the Clinic to participate.

Pre-Registration: To insure receiving Clinic materials, please submit Clinic registration form (attached) and fee, **not later than April 11th, Wednesday. Payment is due prior to the Clinic.**

USA Swimming Clinic Fee: \$25; Clubs usually reimburse participants for their fees. Includes USA Swimming, "The Start," DVD and an Acme Thunder whistle.

YMCA Clinic Fee: \$27; Includes three years registration with YMCA of the USA. If a "Y Only" participant wants USAS DVD and whistle, add \$24.50, with separate check payable to Wisconsin Swimming. *Check with YMCAs about reimbursement.*

Prior to the Clinic: *USA Swimming participants* should review 2012 Rule Book, especially "Official Glossary" and Rules 101.1-105.5 and preview Rules 202.1-205.8.

YMCA participants should review Rule Book especially "Officials Glossary" and Rules 101.1-105.5.

At the Clinic: Trainers will present a comprehensive curriculum including a USA Swimming DVD, "The Start." Trainer will encourage discussion and will explain tests and the Starter-Referee Apprenticeship for USA Swimming certification. Please bring Rule Book and paper and pen for note taking. Beverages and snacks are provided

After the Clinic:

USA Swimming: Take the USA Swimming on-line, open book tests and complete eleven apprentice sessions on deck.

YMCA: Take the YMCA Swimming on-line, open book test.
