Clinic Fee \$25; Includes USA Swimming DVD, "Officiating Swimming" and 2012 USAS mini
Rule Book. Clubs usually reimburse participants for this fee. Registration and fee must be paid prior
to Clinic.

At the Clinic: Clinic includes viewing and discussing the USAS demonstration DVD "Officiating Swimming"
on strokes, turns, relay exchanges and deck jurisdictions. Lecture and lots of discussion are expected. Please
bring paper and pen for note taking. LSC provides Clinic materials, snack, and beverages.

After Clinic: Applicants must pass the on line USAS Criminal Background Check and USAS Athlete
Protection Test prior to applying for USAS Non Athlete Membership. After certification as an Official,
Wisconsin Swimming reimburses the Official for the \$39 Criminal Background Check, when the Official
sends a copy of the invoice to Pat Lewno, LSC Treasurer, 5330 Linden Circle, Racine 43406. Then, the
participant applies for USAS Non Athlete membership, (form available at Clinic), takes USA Swimming on-
line, open book tests and apprentices on deck with certified USA Swimming Officials. A participant's club
usually pays for the annual USAS non-athlete membership dues (\$56 for 2012.)

***From the North or South on Hwy 139/51***

1. Take Exit 192 onto eastbound Hwy 52/Stewart Avenue
2. Proceed to 7<sup>th</sup> Avenue
3. Turn right (South) onto 7<sup>th</sup> Avenue
4. Proceed one block to Garfield Avenue
5. Turn right (West) onto Garfield Avenue
6. Then, immediately, turn left (South)
7. The UWC-MC Field House is the first building on the right (West) side of street

***From the East on Hwy 29***

1. Take Hwy 51 North (not Business Hwy 51) to Exit 192
2. Take eastbound Hwy 52/Stewart Avenue
3. Proceed to 7<sup>th</sup> Avenue
4. Turn right (South) onto 7<sup>th</sup> Avenue
5. Proceed one block
6. Turn right (West) onto Garfield Avenue
7. Then, immediately, turn left (South)
8. The UWC-MC Field House is the first building on the right (West) side of street

***From the West on Hwy 29***

1. Take Hwy 29 to Hwy 52E/Stewart Avenue
2. Take eastbound Hwy 52/Stewart Avenue
3. Proceed to 7<sup>th</sup> Avenue
4. Turn right (South) onto 7<sup>th</sup> Avenue
5. Proceed one block to Garfield Avenue
6. Turn right (West) onto Garfield Avenue
7. Then, immediately, turn left (South)
8. The UWC-MC Field House is the first building on the right (West) side of the street
