



WISCONSIN SWIMMING OFFICIALS' REGISTRATION AND RECERTIFICATION PROCEDURE - 2011

- 1 Complete the enclosed *USA Swimming 2011 Non-Athlete Registration Application*. All officials must be non-athlete members of USA Swimming. This registration is done on a **calendar year** basis.
- 2 Pay the USA Swimming registration fee of **\$55.00 (\$100.50** for a family membership). (Make check payable to Wisconsin Swimming).
NOTE: The registration process is quicker and simpler if you send an individual check. If your club pays this fee for you, please seek reimbursement after you have registered.
- 3 Complete the enclosed *Wisconsin Swimming Officials' Annual Registration Application*. Be sure to include your current e-mail address (please print legibly). Communications from the Officials Committee will be sent via e-mail, therefore, it is important that we have a current e-mail address.
- 4 To Recertify, a Stroke/Turn Official must complete 4 sessions per year, and a Starter/Referee must complete 6 sessions per year.
- 5 To maintain certification, every **even** year, you must complete one of the following:
 - o **Attend** one of the Officials' Recertification clinics during the Fall of every even year

OR

 - o **Online:** Complete and pass with a score of 80% or above the required Re-Certification test(s) for your level (Please be certain to select the "Re-Certification" test from the). Go directly to http://www.usaswimming.org/Online_Testing. Once logged into the USA Swimming website, please be certain to select the "Re-Certification" test from the "Start Test" pull down. Results are sent directly to the Wisconsin Officials Committee Chair and recorded for your recertification.

NOTE: You will receive your credentials in the mail:

- The Wisconsin Swimming Registration Chair will process your USA Swimming membership and a laminated USA Swimming Credentials Card will be sent to you. This credential must be displayed while on deck during all meet sessions that you work. If you are not working during a session, please remain off the deck.
- **Please allow three weeks for processing.**
