Swimmers may not enter an event in their age group in which they have a state, but can swim in the senior category. Any swimmer achieving the state cut time standard after the entry deadline may still compete in that event. Any 8 & under swimmer may swim in any 8 & under event regardless of seed time, but may not swim in 10 & under events in which they have achieved the state cut.

Deck entries will be allowed for high school boy swimmers, up until 30 minutes prior to the session in which they wish to swim. Other deck entries will be accepted only to fill existing heats. Swimming swimmers and MUST be listed on the official entry form. This includes relay only swimmers. Submit current yard times. All events will be timed finals.
