writing at the scoring table prior to the event.

Eligibility: All swimmers must be registered with USA Swimming prior to meet entries

Conduct: All clubs will be responsible for their own swimmers. The meet marshals, meet

directors, and meet referee have the authority to disqualify swimmers found misbehaving. Per USA Swimming guidelines, only swimmers, coaches, and Shorewood Swim Club meet workers will be allowed on the deck. In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera

phones or video recording devices in the locker rooms is prohibited.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian

to ensure compliance with this requirement.
