- Facility: The Klotche Center is an 8-lane, 25 yard indoor pool with non-turbulent lane markers and backstroke flags. Pool depth ranges from 14' at the starting end to 3-1/2' at the turning end. Starting block height is 30". Timing system is a Colorado 5 with backup button and two manual backup watches per lane. *The Competition Course has not been certified in accordance with USA Swimming Rule 104.2.2C (4)*
- Timing: Colorado 6 timing system, in addition to manual timing (two timers with watches)
- Rules: 2011 USA Swimming & Wisconsin Swimming rules shall prevail
- Time Schedule: **AM Warm Ups:** 8:00-8:45  
30 minutes general warm up + 15 minutes with 2+ sprint lanes as needed  
**AM Meet Start:** 8:50  
  
Tentative timeline to be posted Wednesday, April 27<sup>th</sup>, on the Shorewood Swim Club web site ( [www.shorewoodswimclub.com](http://www.shorewoodswimclub.com)).
- Meet Format: All events are timed final and pre-seeded. Swimmers must report directly to the blocks for all events.
- Entries: Swimmers will be allowed up to five (5) individual events and one (1) relay for the meet. Entries should be submitted in most current yard times.
- Relays: Mixed gender Pineapple Relays will be offered by age group (6x25 and 6x50-any combination of boy/girl). Relay sheets will be available in the coach's packet at the beginning of the meet. Due to the depth at the non-starting end of the competition pool, the 2<sup>nd</sup>, 4<sup>th</sup> and 6<sup>th</sup> leg of the 6 x 25Y relays will start in the water.

- Awards:** Pentathlon awards will be given to individuals with the 8 highest total scores based on the HyTek Age Group Point system ([hytek point system](#)) for each gender and age group. Ribbons will be awarded to the top 16 swimmers in each event. Winning relay teams will be awarded pineapples and other assorted fruit. All swimmers will receive a commemorative meet T-Shirt.
- Admissions:** \$3.00 per spectator and \$3.00 per heat sheet
- Eligibility:** All swimmers must be registered with USA Swimming prior to meet entries being submitted. Coaches/entry chairs will be notified by Wisconsin Swimming of any swimmer not registered, or registered for the meet incorrectly, and the swimmers must be properly registered prior to the start of the meet. Swimmer's age as of May 1<sup>st</sup> will determine age group eligibility. Out of state swimmers must bring current USA Swimming card to the meet.
- Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Disabled Swimmers:** If entering a disabled swimmer, please make a note to that effect on the meet entry.
- Entry Deadline:** Final entries will be due **Wednesday, April 20<sup>th</sup>**. All teams are encouraged to use e-mail entries in Hy-Tek .cl2 format.

- Deck Entries: Deck entries at \$5.00 per event will be accepted to fill open lanes, at the discretion of the meet director. Submitting club must supply full name, birth date, and a valid registration number. Teams deck entering will be responsible for any fines or fees levied due to incorrect data. Swimmers deck entering at the meet will not receive a T-Shirt.
- Deck Registration: Deck Registration will not be allowed at this meet.
- Final Results: Final results will be e-mailed to each participating team. Results will be posted [www.shorewoodswimclub.com](http://www.shorewoodswimclub.com) and [www.wisconsinswimming.org](http://www.wisconsinswimming.org).
- Conduct: All clubs will be responsible for their own swimmers. The meet marshals, meet directors, and meet referee have the authority to disqualify swimmers found misbehaving. Per USA Swimming guidelines, only swimmers, coaches, and Shorewood Swim Club meet workers will be allowed on the deck. In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.
- Lost & Found: Lost and found items will be located near the admissions table.
- First Aid: A lifeguard will be responsible for first aid and medical emergencies at the facility.
- Officials: Head Referee – Pat Weisling. There will be a minimum of two starter referees and four total officials.
