- Facility: 25 yd. pool with six 7' lanes, non-turbulent lane markers and backstroke flags, 30" starting blocks, 12' depth at starting end, 4'6" depth at turn end, custom designed gutters and bulkhead. The Competition Course has not been certified in accordance with USA Swimming's Rule 104.2.2C(4).
- Timing: Colorado VI timing system, in addition to manual timing (two timers with watches)
- Rules: 2011 USA Swimming & Wisconsin Swimming rules shall prevail. Three point entries from the starting end of the pool during general warm-ups will be enforced.
- Time Schedule: Warm Ups: 7:30-8:15 general warm-ups  
8:00-8:15 at least two sprint lanes, more as needed  
Meet Start: 8:20  
Tentative timeline to be posted Wednesday, November 9<sup>th</sup>, on the Shorewood Swim Club web site ( [www.shorewoodswimclub.com](http://www.shorewoodswimclub.com)).
- Meet Format: All events are timed final and pre-seeded. Swimmers must report directly to the blocks for all events.
- Entries: Swimmers will be allowed up to four (4) individual events and two (2) relays for the meet.
- Relays: Relay sheets will be in the coach's packets. Coaches should complete the relay sheets, and return them to the scoring table by 8:00. Changes can be made in writing at the scoring table prior to the event.
- Awards: Plaques for all swimmers  
Individual events Bars 1<sup>st</sup> – 12<sup>th</sup>  
Relay events: Ribbons 1<sup>st</sup> – 6<sup>th</sup>
- Admissions: \$3.00 per spectator and \$3.00 per heat sheet
- Eligibility: All swimmers must be registered with USA Swimming prior to meet entries being submitted. Coaches/entry chairs will be notified by Wisconsin Swimming of any swimmer not registered, or registered for the meet incorrectly, and the swimmers must be properly registered prior to the start of the meet.
- Disabled Swimmers: If entering a disabled swimmer, please make a note to that effect on the meet entry.

- Entry fees: Individual events: \$3.50  
Relay events: \$12.00  
Splash fee: \$2.00 per swimmer

- Deck Entries/Reg. Deck entries will be accepted to fill open lanes, and at the discretion of the meet director. Submitting club must supply full name, birth date, and a valid registration number. Teams deck entering will be responsible for any fines or fees levied due to incorrect data. An additional surcharge of \$5.00 per event will be charged. Deck Registration will not be allowed at this meet.
- Final Results: Final results will be e-mailed to each participating team. Results will also be posted [www.shorewoodswimclub.com](http://www.shorewoodswimclub.com) and [www.wisconsinswimming.org](http://www.wisconsinswimming.org).
- Concessions: Assorted food and beverage items will be available at the meet.
- Conduct: All clubs will be responsible for their own swimmers. The meet marshals, meet directors, and meet referee have the authority to disqualify swimmers found misbehaving. Per USA Swimming guidelines, only swimmers, coaches, and Shorewood Swim Club meet workers will be allowed on the deck. In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.
- Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Lost & Found: Lost and found items will be located near the admissions table.
- First Aid: A lifeguard will be responsible for first aid and medical emergencies at the facility.
- Officials: The Head Official will be Pat Weisling. There will be a minimum of two starter referees and four total officials.
