- Timeline:** A tentative meet timeline will be available on or before Wednesday, June 6th on the Shorewood Swim Club website.
- Meet Format:** **We will be using Positive Check-In for all events.** The check in will close 45 minutes prior to the start of each session. The meet will be timed finals. Swimmers must report directly to the blocks for all events. Fly-over starts will be used for all events. The Friday night 400 free and 400 IM will be limited to the top 24 (14&U) and top 40 (Senior) swimmers in each event. Open slots will be filled if there are not 40 entrants for one gender in each event. The host club reserves the right to limit all 200 meter events to no fewer than five (5) heats, in the interest of following the 4-hour meet session guideline (as needed).
- Eligibility:** All swimmers must be registered with USA Swimming by the entry deadline. Coaches/entry chairs will be notified by Wisconsin swimming of any individual not registered or registered incorrectly, and the swimmer must be properly registered by the start of the meet. Swimmers age as of June 10th, 2012 will determine age group eligibility for the meet. Out of state swimmers should bring proof of USA Swimming membership to the meet.
- Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Entries:** Each swimmer may compete in one (1) event Friday and up to three (3) individual events, plus relays, Saturday and Sunday. Entries should be submitted using **Long Course Meter Times**. This meet will be run using HyTek Meet Manager. All entries should be submitted in a HyTek compatible file format (as an e-mail attachment) with a hard copy. Entries will be limited to 3500 individual entries for the meet.
- Entry Fees:** \$5.00 per individual event
\$12.00 per relay
\$2.00 splash fee per swimmer
\$6.00 facility fee per swimmer
Checks made payable to "**Shorewood Swim Club**".
All fees must accompany entries and are non-refundable.
- Entry Deadline:** Entries must be received by **Wednesday, May 30th, 2012**. Entries should be submitted by Hy-Tek file via e-mail, immediately followed by the hard copy, fees and waiver via standard mail.

Relays:

Relay sheet will be provided in the coach's packets at the start of the meet. Coaches should complete the relay sheet and return them to the pool office no later than 30 minutes before the start of the session.

Deck Entries:

Deck entries (at \$10.00 per event) will be allowed to fill open lanes at the discretion of the meet director. Submitting team must supply full name, birthdate, and a valid USA Swimming registration number. Teams deck entering will be held responsible for any fines or fees levied due to incorrect data.

Deck Registration:

Deck registration will not be allowed at this meet.

Awards:

All swimmers will swim as one class by age group and gender, but will be separated by A-BB and B-C classes for award purposes in each age group. Medals will be given for 1st-3rd in individual events and ribbons will be awarded for 4th – 16th places. Ribbons will be awarded for 1st – 6th in relay events. Swimmers will be eligible for awards in the class in which they are seeded.

**Heat Sheets/
Admission:**

\$3.00 per session heat sheet and \$4.00 per day admission. Heat sheets will be made available after positive check in. All heat sheets/admission are cash only.

Final Results:

All teams will receive final results via e-mail by Wednesday, June 15th. Results will also be available on the Shorewood Swim Club web site, and the Wisconsin Swimming web site.

First Aid:

First aid will be available from the lifeguards

Conduct:

Each team will be responsible for the conduct of its swimmers and parents. Misconduct will be dealt with by the meet marshals, meet director, and Head Official, and may result in disqualification from participation and/or immediate expulsion from the premises. Smoking is not allowed within 50 feet of the facility. No food or coolers may be brought into the building, due to city code. There can be no lounging in the hallway between the main lobby and cafeteria area, due to Brown deer fire codes. Per USA Swimming rules, only coaches, swimmers and meet workers are allowed on deck and in the lower bleacher areas. Spectators must sit in the upper grandstand and leave the lower grandstand for swimmers and coaches. Swimmers are encouraged to stay in the lower bleachers. Coaches must display valid 2012 USA Swimming credentials at all times. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

Officials:

Head Official – Pat Weisling. There will be a minimum of two starter referees and four officials in total each session.
