- WARMUP:** **AM-Warm-up:** 8:00-9:00 AM as follows: 8-8:30 circle swim all lanes NO diving. Sprint and pace lanes will be added as needed beginning at 8:30. Meet starts at 9:10 AM.
- PM Warm-up:** A 45 minute warm-up will begin immediately at the conclusion of the AM Session. First 25 minutes will be circle swim. Sprint and Pace lanes will be added as needed for the final 20 minutes. Meet will begin 55 minutes after the conclusion of the AM Session. **"Feet First Three-Point Entry" DURING BOTH SESSIONS OF GENERAL WARM-UPS WILL BE ENFORCED.** Failure to follow warm-up guidelines may result in disqualification from the next individual event.
- FACILITY:** Eight lane, 25 yard pool, 13 foot at start and 5"10" at turn end. 30" blocks with non-turbulent lane markers and backstroke flags. The pool features a 12 ½ by 14 ½ foot full color, digital display scoreboard. Concessions will available. No food allowed in pool area. The Competition Course has not been certified in accordance with USA Swimming's Rule 104.2.2C(4).
- TIMING:** Colorado System 6 timing system with aqua grip touch pads. Two backup timers per lane will be used.
- OFFICIAL RULES:** **Age as of October 2, 2010.** Current Official 2010 Short Course USA and Wisconsin Rules shall prevail for this meet. Swimmers must be currently registered USA Swimming members. USA Swimming deck registrations will not be accepted. Out of state entrants must bring current USA Swimming cards. Coaches must display their current Coaches Card while on deck. Coaches should notify meet officials of any disabled swimmers upon arrival at the meet.
- DISABLED SWIMMERS:** Coaches are encouraged to inform Officials and the Meet Director of any disabled swimmer's needs prior to warm-ups.
- OFFICIALS:** BOB WESEL (Head Referee)
- ENTRY LIMIT:** **AM** -Swimmers may compete in **Four (4)** individual events. **PM** -Swimmers may compete in **Three (3)** individual events. Entry Limit per session will be 1000 Swims.
- LIMITED EVENTS:** The 400 IM and 500 Free will be positive check-in and may be limited to the top 30 entered times. The 1000 will be positive check in and may be limited to the top 20 entered times. Swimmers must provide their own counters for the 500 Free and their own counters and timers for the 1000 Free. 1000 will be swum fastest to slowest, alternating women and men.
- SESSION AGE LIMITS:** The AM Senior Circuit Session is limited to 13&Over Swimmers. The PM Age Group Distance Session is limited to 12 & Under Swimmers. Each session will swim as one class. AM-13 & Over, PM – 12 & Under
- FEES:** Individual events \$4.00 per event. \$3.00 LSC surcharge per swimmer. Deck Entries will be \$8.00 and will be at the discretion of the meet director depending on the availability of open lanes. No new heats will be created once seeded. Deck entries will close 30 minutes prior to the beginning of the session. **Entry Fees must accompany waiver/recap forms and are not refundable.**

ENTRY

DEADLINE: **Wednesday, September 22, by 6:00pm.** Email Entries are preferred. Meet Entry Fees and waiver may be sent via standard mail and must be received by Friday, September 24, 2010. No phone entries will be taken. This meet is being run with HY-Tek swim software. No seed times will be changed once the entry chair has seeded the meet.

ADMISSIONS: Admission for spectators over 13 years old is \$4.00 each session. Heat Sheets included.

CONDUCT: All coaches are responsible for the conduct of their swimmers and will see that their club has proper supervision at all times. Meet Marshals have the authority to remove any swimmer and/or spectator from the meet for any violation such as improper behavior, damage to property, etc. No smoking on the premises. Cell phones and other recording devices are not allowed in the locker rooms. Please encourage your parents and swimmers to clean up after themselves.

“Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer’s legal guardian to ensure compliance with this requirement.”
