- WARMUP:** Warm-up: 8:00-9:00 AM. Wisconsin Swimming warm-up procedures will be in effect. Warm-up will have 30 minutes of circle swimming with no racing starts. **FEET FIRST THREE-POINT ENTRIES FROM THE STARTING END DURING GENERAL WARM-UPS WILL BE ENFORCED,** unless performing one way starts. The second 30 minutes, sprint lanes will be opened as needed. Violators of the Wisconsin Swimming warm-up procedures may be subject to disqualifications.  
Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- FACILITY:** Eight lane 25 yard pool, 12'4" at start and (3'6")foot at turn end. 30" blocks with non-turbulent lane markers and backstroke flags. The Competition Course has not been certified in accordance with USA Swimming's Rule 104.2.2C(4). Concessions will be available with a variety of hot/cold foods and beverages. No food or beverage allowed in the pool area.
- TIMING:** Daktronics Timing System will be used with a manual back-up button, plus two back-up timers for each lane. Should the automatic system fail, a gun or horn start will be used.
- OFFICIAL RULES:** **Age as of May 5, 2012** Current Official 2012 Short Course USA and Wisconsin Rules shall prevail for this meet. Swimmers must be currently registered USA Swimming members. Out of state entrants must bring current USA Swimming cards. Coaches must display their current Coaches Card while on deck. Coaches should notify meet officials of any disabled swimmers upon arrival at the meet. USA Swimming deck registrations will not be accepted.
- OFFICIALS:** TBA, Starter/Referee, Ben Durley
- ENTRY LIMIT:** **Swimmers may compete in Four (4) individual events.**
- LIMITED EVENTS:** The 400 IM and 500 Free will be positive check-in and may be limited to the top 30 entered times. The 1000 will be positive check in and may be limited to the top 20 entered times. Swimmers must provide their own counters for the 500 Free and counters/timers for the 1000. 1000 will be swum fastest to slowest, alternating women and men. Heats/events may be combined at Meet Directors discretion.

- FEES:** Individual events \$4.00 per event. \$2.00 LSC surcharge per swimmer entered in at least one individual event.  
Entry fees must accompany entry forms. Recap statement must be completed and the waiver form signed. Money used for reservations is nonrefundable, and cannot be used to offset cost of relays, deck seeding or splash fees. **Checks should be made payable to SOUTHWEST AQUATIC TEAM.**
- Deck Entries:** The entry fee for deck entries will be \$8.00. Deck entries will be allowed at the discretion of the meet director and only to fill open lanes if the time permits. (Additional heats will not be added). Deck entries close 30 minutes prior to the start of the session.
- ENTRY DEADLINE:** This meet is being run with Hy-tek swim software. Entries via hytek file must be emailed to Tina Gupton: **NO LATER than 5:00 pm on Monday, April 23rd.** Entries can be emailed to **Tina at: [caurea@sisna.com](mailto:caurea@sisna.com)**

- ADMISSIONS:** Admission for spectators over 13 years old is \$4.00. Heat Sheets included.
- AWARDS:** None
- Coaches Packet:** Coaches may pick up their packets at the Positive Check in Table located inside the pool entry doors by concessions. **Any monies owed must be paid before you can obtain your packet.** Please be prepared to show your U.S.A.S. coach's card at the time you pick up your team packet. **Coach's cards must be visible at all times on deck.**
- Conduct:** Each team is responsible for the conduct of its swimmers. In compliance with the Video Prevention Act the use of any recording devices is prohibited in the locker rooms.  
  
Meet Marshals shall have the authority to remove any swimmer/s from the meet for any violation such as improper behavior damage to property, etc. Such teams are responsible financially for damage of property. There shall be No Smoking permitted at any time on the premises. **Please make sure your team's area on deck and rest area is picked up at the end of each session.**
- FOOD:** A selection of hot and cold food and beverages will be available in concessions.
- First Aid:** Injuries must be reported to the Lifeguard AND to the Meet Director. A first aid kit will be located at the Lifeguard station.
- Lost & Found:** An area for lost and found will be located by the concessions. After the meet items will be donated.
- Meet Results:** Results will be posted on the Wisconsin Swimming website.
