Facility: 25-yard pool with 6 lanes. Starting pool depth is 11 feet with 30-inch starting blocks.

Turning end is 4 feet deep. The Competition course has not been certified in accordance

with 104.2.2C(4).

Timing System: Daktronics timing system and touch pads will be utilized, along with two back-up timers for

each lane.

Schedule/Warm-ups: Saturday and Sunday Morning Sessions (9-10, 11-12):

Warm-ups at 8:00 am, Meet Starts at 9:15 am.

Saturday and Sunday Afternoon Sessions (6 & U, 7-8, 13-14, OPEN):

Warm-ups will be for one hour, and will precede the start of the afternoon session.

Morning Sessions will have 30 minutes of circle swimming with no racing starts. Sprint lanes will be opened during the second 30 minutes. The same format will be followed for

the Afternoon Sessions.

Feet first three-point entries from the starting end of the pool during general warm-

ups will be enforced for all sanctioned/approved competition.

Swim Officials: Starter/Referee: Judy Felts, TBA

Stroke/Turn: TBA

Rules: USA and Wisconsin Short Course rules shall prevail. All USA registered swimmers are

welcome to participate. Age is as of January 8, 2011.

Entry Deadline: Entry Chairperson must receive entries no later than 5:00 pm, Tuesday, December

28, 2010. Please submit entries on HY-TEC by e-mail or disk. Hard copy back-up, waiver, and fees are due to the Entry Chairperson no later than 5:00 pm, Tuesday,

December 28, 2010.

Entry Limit: Each swimmer may swim a maximum of 3 individual events per day and 1 relay.

Positive check-in is required for swimmers in the 500 and 1650 free events no later then 30 minutes before the meet starts. The 500 and 1650 free events will be run fastest to

slowest.

* Entries for the 13-14 1650 free will be limited to the top 6 boys and the top 6 girls.

* Entries for the Open 1650 free will be limited to the top12 boys and the top 12 girls. Swimmers will be notified if they did not make it into these events, so they may choose

another event. The 1650's may be seeded as one event by time, but will be separated for awards.

Entry Fees: Entry fees will be \$3.50 per individual event and \$10.00 per relay. A one-time **\$2.00**

splash fee must be paid for each swimmer entered into the meet (WI LSC Rule). All fees and signed waiver form must accompany entries. Checks should be made payable to

WAUSAU TIDE SWIM CLUB.

Deck Entries: Deck entries will only be accepted at the discretion of the Meet Director and only to fill

open lanes. Scratching one event to deck seed in another will not be allowed. Deck entry fee is \$6.00 per Individual Event, \$14.00 per Relay. Deck Entry closes 30 minutes before

the start of the meet.

Admission: \$3.00 per day

Heat Sheets: \$4.00 per day.

Awards: Ribbons will be awarded $1^{st} - 12^{th}$ place for Individuals, and $1^{st} - 3^{rd}$ place for relays.

Trophies will be awarded for Individual High Points for 1st – 12th place finishes in the following categories (6 & under, 7-8, 9-10, 11-12, 13-14, Open). **Note:** Points achieved in Open events will not be counted for Age Group Awards. Limit one trophy per swimmer.

Format: 8 and Unders may report to the designated staging area. All other swimmers report to the

blocks prior to your event. This is a pre-seeded meet. Heat/Events may be combined due

to time constraints, but will be awarded separately.

Conduct: All coaches are responsible for the conduct of their swimmers. Any violation such as

improper behavior or damage to property, etc. may result in removal of the swimmer from

the meet and/or disqualification of swimmer's individual events.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Food: Concessions will be available in the cafeteria. Swimmers are allowed sipper bottles on

deck. No food or drink allowed in pool area. Please make sure swimmer's area on deck

and in the rest area is picked up after each session.

First Aid Kit: Please report any injuries to the Lifeguard and to the Meet Director. A First Aid Kit is

available through the lifeguard.

Lockers: Women and Men's lockers are available. Swimmers are responsible for securing their own

belongings. Wausau Tide will not be responsible for lost articles.

In accordance with the Federal Video Voyeurism Prevention Act of 2004 - the use of

camera phones or video recording devices in the locker rooms is prohibited.
