Concessions will be available, No food or beverage is allowed in the pool area. The competition course has not been certified in Accordance with USA swimming rule 104.2.2[c]
TIMING:	Colorado System 6 timing system with aqua grip touch Pads
OFFICIAL RULES:	Current official 2010 Long Course USA and Wisconsin Rules shall prevail. Swimmers must be registered USA swimming members. Age as of May 22, 2010. Out of state entrants must bring current USA Swimming cards. Coaches must display their current Coaches Card while on deck. Coaches should notify meet officials of any disabled swimmers upon arrival at the meet. The 8 & Under 100 relays will have the 2 nd and 4 th swimmers start in the water due to pool depth.
