8:30-9:00 AM one way sprints with dive lanes 3&4, push 50's
1&6, circle lanes 2&5
Sit and slide entries during general warm up will be enforced.
Failure to follow warm-up guidelines may result in Disqualification from
the next individual event.

- FACILITY:** Eight lane 25 yard pool, 5'6" at start 3'6" at turn end.
30" blocks with non-turbulent lane markers and
Backstroke flags. Concessions will be available, No food or beverage is
allowed in the pool area. The competition course has not been certified

- TIMING:** Colorado System 6 timing system with aqua grip touch
Pads
- OFFICIAL RULES:** Current official 2012 Short Course USA and Wisconsin
Rules shall prevail. Swimmers must be registered USA swimming
members. Age as of May 19, 2012. Out of state entrants must bring
current USA Swimming cards.
Coaches must display their current Coaches Card while on
deck. Coaches should notify meet officials of any disabled
swimmers upon arrival at the meet.
- OFFICIALS:** Al Brink
- ENTRY LIMIT:** Swimmers may compete in five(5) individual events plus relays.
Swimmers must provide their own counters for the 500/1000 Freestyle.

- FEES:** Individual events \$4.00 per event and \$12.00 per relay. The LSC splash is \$2.00 for each swimmer swimming in at least one individual event. Deck entries will be \$6.00 per event or \$15 per relay and will be at the discretion of the Meet director. No new heats will be created. Entry fees must accompany the official entry forms and are not refundable.
- ENTRY DEADLINE :** Completed entry form ,waiver and fees must be received no later than May 9,2012. No phone entries will be taken. This meet is being run with Hy-Tek swim software. Please submit entries via disk or e-mail. No seed times will be changed once the meet is seeded.
- DISABLED SWIMMERS:** Coaches, please alert meet management as to any special needs for your swimmers.
- RULES:** 2012 USA Swimming and Wisconsin LSC rules will prevail.
- ADMISSIONS:** Admission for spectators over 13 years old is \$3.00. Heat sheets are \$3.00.
- CONDUCT:** Each team is responsible for the conduct of its swimmers In compliance with the VIDEO PREVENTION ACT the use of Any recording device is prohibited in the locker rooms.
- Any swimmer entering the meet unaccompanied by a USA Swimming member coach must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with the requirement.*
- USA Swimming shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
- AWARDS:** All ages 7&U,8,9,10,11,12,13,14,15&O events –ribbons 1-16 places
Relays – ribbons 1-6 places
Age High point awards 7&U,8,9,10,11,12,13,14,15&O
All awards will be given to the coaches at the end of the meet, no awards will be mailed
