A coach from your team must be on deck during warm-ups. Swimmers not following procedures could be disqualified at the discretion of meet officials.

THREE POINT ENTRIES FROM THE STARTING END OF THE POOL DURING GENERAL WARM-UPS WILL BE ENFORCED FOR ALL

SANCTIONED/APPROVED COMPETITION.

Entries: Only entries from teams invited to the meet will be accepted. Swimmers may

compete in four (4) individual events per day plus two (2) relays. Entries will be

accepted up to a maximum of 1200 entries for the meet. This meet will be run using Hy-Tek meet manager. All teams are required to email entries in Hy-Tek Commlink format by the deadline below.

All Relays are mixed multi-age group events to maximize the ability for smaller teams to enter relays teams in the meet. Each team may enter a up to four relays teams per event.

There will be no deck seeding or deck entries for this meet.

Entry Deadline:

Friday, October 2nd. The entry chair must receive, Hy-Tek entries, a completed entry form and signed waiver no later than Friday, October 2nd. A completed entry form and signed waiver and payment must be received by Tuesday, Oct 6th. No entries will be taken over the phone. Email entries are encouraged and can be sent. All entries must be emailed in Hy-Tek format, hard copy entries are not acceptable.

Official 2009 Short Course USA Swimming Rules shall prevail for this meet. Swimmers must be registered WISCONSIN USA Swimming swimmers. Swimmers age is as of October 11th, 2009.
