Location: Waunakee HS Pool, 100 School Dr., Waunakee, WI 53597

Facility: Eight lanes, 25 yards flush deck, non-turbulence lane dividers and backstroke flags, with 18" height starting blocks. Pool is 7.5 feet deep at the starting blocks and 3.5 feet deep at the non starting end of the pool.

Please be advised that due to the depth of the non-starting end of the pool, the 2nd and 4th leg of all 100-Yard/Meter relays will start in the water.

The Competition Course has not been certified in accordance with USA Swimming's Rule 104.2.2C(4).

Timing: Colorado System 5 with backup watches. All events are timed finals.
Computerized score board for all lanes.

There will be at least three certified USA Swimming Officials on deck at all times.

Rules: Current USA Swimming and Wisconsin LSC rules shall prevail for this meet.
Swimmers do not have to be registered with USA Swimming, unless they are swimming for a USA-S club. Events/heats may be combined as directed by the Meet Referee during the meet and by Meet Director for pre-meet seeding. Breaks may be added if need is determined by Meet Referee.

Warm-ups: Wednesday PM warm-ups are 4:30-5:30 pm with competition starting at 5:40 pm.

All lanes open for circle swim for the first 30 minutes; sprint lanes open for second 30 minutes in lanes one and eight with the other lanes remaining open for circle swim. Team lane assignments will be available in the coaches' packets.
"SIT AND SLIDE ENTRY" or "THREE POINT ENTRY" ONLY. Meet Director/Marshals will be on deck during the entire warm-up, with the authority to recommend disqualification.

- Entry Fees: \$2.00 LSC splash fee per swimmer, \$2.00 per individual event, and \$4.00 per relay
- Deck Entries: Deck entries will be allowed to fill open lanes. No additional heats will be added. Deck seeding will close 30 minutes prior to the start of the competition. There are no additional Deck Entry surcharges, however, you must pay the normal Entry Fees listed above.
- Deck USAS Registration WAUN will not accept deck USA-S registration. An unregistered USA-S swimmer for a USA-S team may not compete, however, non-USA-S swimmers for non-USA-S teams are not required to be USA-S registered.
- Age Groups: 8&U, 9-10, 11-12, 13-14, 15 and Over
Age as of the first day of the meet.
- Awards & Scoring: Individual Events, places 1st thru 16th. 20, 17, 16, 15, 14, 13, 12, 11, 9, 7, 6, 5, 4, 3, 2, 1. Relay Events, places 1st thru 8th: 40, 34, 32, 30, 28, 26, 24, 22, 18, 17, 12, 10, 8, 6, 4, 2. Awards for relay events will consist of ribbons for 1st-8th place. Awards for individual events will consist of ribbons for 1st-16th place. Coaches will be permitted to pick up awards at the end of each session. Awards will not be mailed.
- Coaches: All coaches can pick up their coaches packets at the timing table on the pool deck. **Any monies still owed must be paid before you can obtain your packet.** Please be prepared to show your current USAS Coaches membership card at the time you pick up your team packet, if your team is a USA-S team. **USA-S Coaches' USA-S membership cards must be visible at all times on deck.** Entry changes are due in writing to the Clerk of Course/Meet Director at the timing table on the pool deck 30 minutes prior to the start of the meet.

Conduct:

All teams are responsible for the conduct of their swimmers. The Meet Director/Marshall, at his/her discretion, shall remove any swimmers or spectators who behave in a disruptive or disorderly manner.

In accordance with the Federal Video Voyeurism Prevention Act of 2004 - the use of camera phones or video recording devices in the locker rooms is prohibited.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
