entry form. This includes relay only swimmers. Submit current yard times.

Final

Seeding: All individual events will be pre-seeded. 8 & under events will be staged.

Conduct: Each team is responsible for the behavior of their swimmers. The Meet Director or Meet Marshall may remove any swimmer from competition for disruptive or disorderly behavior. In accordance with the Federal Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is strictly

prohibited.

Coaches: All coaches must pick up their coaches packet in person and must show their coach's card. If a coach does not
