**Facility:** Eight or ten lane, 25 yard pool. Pool depth is 13 feet at the start end and 5'10" feet at the bulkhead (turn end). Blocks are 30" high. The pool features a 9'x13' full color, digital display scoreboard. Concessions will be available. No food or beverage is allowed in the pool area. The competition course has not been certified in accordance with USA Swimming's Rule 104.2.2C(4).

**Timing:** Colorado System 6 timing system with aqua grip touch pads.

**Rules:** Official 2011 Short Course USA Swimming Rules and Wisconsin Swimming Rules shall govern the conduct of this meet. Swimmers must be registered as USA swimmers. Age is as of November 6, 2011. Coaches must display their Coaches Card while on deck.

## Schedule: *Sunday – All races are timed finals.*

AM session warm-ups:	7:00 – 8:00 AM
AM session begins:	8:05 AM
PM session:	Warm-ups will begin immediately at the conclusion of AM session and the meet will begin 65 minutes after the start of PM session warm-ups.

The afternoon warm-ups will start as soon as the morning session has been completed. The afternoon session will begin 1 hour after the start of warm-ups. The meet director will notify each club as to the approximate time for all sessions once all meet entries have been received.

Failure to follow warm-up guidelines may result in disqualification from the next individual event. Feet first three point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition in accordance with the recent change to Policy 4.5.2(a)

**Officials:** Head Official: Tim McAvoy

**Entries & Eligibility:**

All entries will be taken when accompanied by full payment. Swimmers may compete in four (4) events per day plus relays. Deck entries will only be allowed if there are open lanes available. All swimmers must be registered USA swimmers and their USA Swimming number MUST be listed on the official entry form. This includes relay only swimmers. Submit current yard times.

**Completed entry form, signed waiver and fees must be received no later than Tuesday, October 25, 2011.** Any questions concerning entries should be directed to Sara Beam, Meet Entry Chair at 262-970-0641. If you choose to email you're your entry file it must be received by October 25, 2011 and signed waiver and fees received by October 25, 2011.

**Entry Fees:** \$4.00 per individual event  
\$10.00 per relay event  
\$2.00 per swimmer in an individual event for LSC tax (splash fee)  
*Entry fees must accompany the official entry forms and are not refundable.*

**Admissions:** \$3.00 per spectator over the age of 12. Heat sheets are an additional \$3.00.

**Awards:** *Individual events:* 1<sup>st</sup> – 3<sup>rd</sup> place - Medals  
*Relay events:* 1<sup>st</sup> – 8<sup>th</sup> place - Ribbons  
4<sup>th</sup> – 16<sup>th</sup> place – Ribbons  
**All awards will be bagged and given to the coaches at the end of the meet**

**Scoring:** Sixteen place scoring will be used for individual events. Relay event scores will be doubled.

**Final**

**Results:** Final results will be posted at [www.wisconsinswimming.org](http://www.wisconsinswimming.org) and e-mailed to attending teams.

**Seeding:** All individual events will be pre-seeded.

**Conduct:** Each team is responsible for the behavior of their swimmers. ***The Meet Director or Meet Marshall may remove any swimmer from competition for disruptive or disorderly behavior. In accordance with the Federal Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is strictly prohibited.***

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement

**Coaches:** All coaches must pick up their coaches packet in person and must show their coach's card. If a coach does not present a USA registration card they will not be allowed on deck and the swimmers for the team will be assigned to a USA Swimming certified coach for warm-ups.

**Medical:** Please indicate any special needs your swimmers may have on the entry form. We will do everything possible to accommodate them. This notification should include any existing conditions that may require meet management to activate the emergency response plan. Building personnel are trained in procedures required by Blood Borne Pathogens laws and will be responsible for any clean up required.
