

**2010 Wisconsin Open Water State Championships**

- DATE:** Monday, August 2<sup>nd</sup>, 2010
- LOCATION:** Lake Andrea at the Pleasant Prairie Lakeview RecPlex – 9900 Terwall Ter. Pleasant Prairie, WI 53158
- FACILITY:** Lake Andrea is a spring fed lake with depths from 0 to 30 feet. Start and finish is land based with a sand bottom. The course is measured using a GPS system.
- Timing System:** A fully automated timing system with timing chips will be used. There is a \$50 fine for lost timing chips.
- CLASSIFICATION:** Open Water State Championship Meet
- TENTATIVE SCHEDULE:** The timeline listed below is an approximation. The exact timeline will be posted on [www.wisconsinswimming.org](http://www.wisconsinswimming.org) after all entries have been received.
- Saturday AM:** Registration opens at 7:30am. Meet starts at 9:00am.
- WARM-UPS:** Warm-ups will occur in the Lake and is open throughout the meet.
- ENTRIES:** Swimmers may enter one (1) event. Each age group is offered one distance. Swimmers should enter as a "No Time" (NT). Entries may be done using Hy-Tek TM. Teams may also submit entries using the team registration sheet attached below.
- ENTRY DEADLINE:** Entries **must** be e-mailed to [BSTentries@gmail.com](mailto:BSTentries@gmail.com) no later than 6:00pm **Thursday, July 22<sup>nd</sup>, 2010**. Your completed entry form, signed waiver, and entry fees must be received no later than 6:00pm **Monday, July 26<sup>th</sup>, 2010**.
- A psych sheet will be posted by Tuesday July 27<sup>th</sup>, 2010 on the Kenosha Barracuda Website. If there are any meet management errors with your entry, you must contact Robert Goll by **Wednesday, July 28<sup>th</sup>, by 9:00 am** to correct any errors. No changes will be allowed, only corrections due to meet management errors. No additional entries will be accepted, so please review your entries carefully before e-mailing them on Thursday July 22<sup>nd</sup>.
- ENTRY FEES:** \$20 for pre-registered USA swimmers.  
\$30 for same day registration of USA swimmers.  
\$5 LSC Splash Fee per athlete.
- TIME STANDARDS:** There are no qualifying time standards for this meet.
- SCRATCH RULE:** There will be no penalty for scratching.
- POSITIVE CHECK-IN:** This meet is pre-seeded. All swimmers must report to the registration area before they swim to receive a timing chip, body marking, cap, wave number, and goodie bag.
- FORMAT:** Swimmers in an event will swim at one time in pre-determined waves. All swimmers from one event will begin before another event is started. There may be multiple events in the water at one time. There will be individual placing (awards) and scoring.
- Swimmers with a disability:** Please indicate on the entry form any special needs for those athletes requiring assistance. Also, please inform the **Meet Referee** of those needs prior to the start of the meet.

The use of cell phones and recording devices are strictly forbidden in the locker rooms. Meet Marshal will periodically inspect the locker rooms for compliance.
